Railroad is 1,380+/- feet away from site. Location is Approx. 180 feet of an existing overhead power line. Nearest water well is 1,416 +/- feet from site (RECEIPT:9053325; PERMIT:379; USE: DOMESTIC). There is a small ephemeral playa located 834 +/- feet northeast of location. This location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COAs are needed for this location. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit which will be determined at the time of installation.
