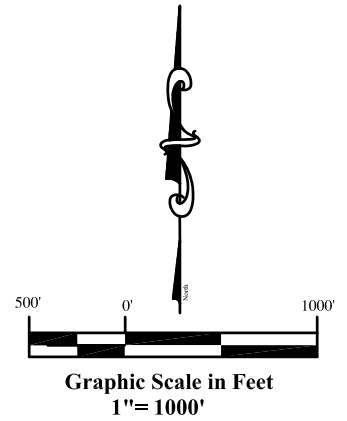
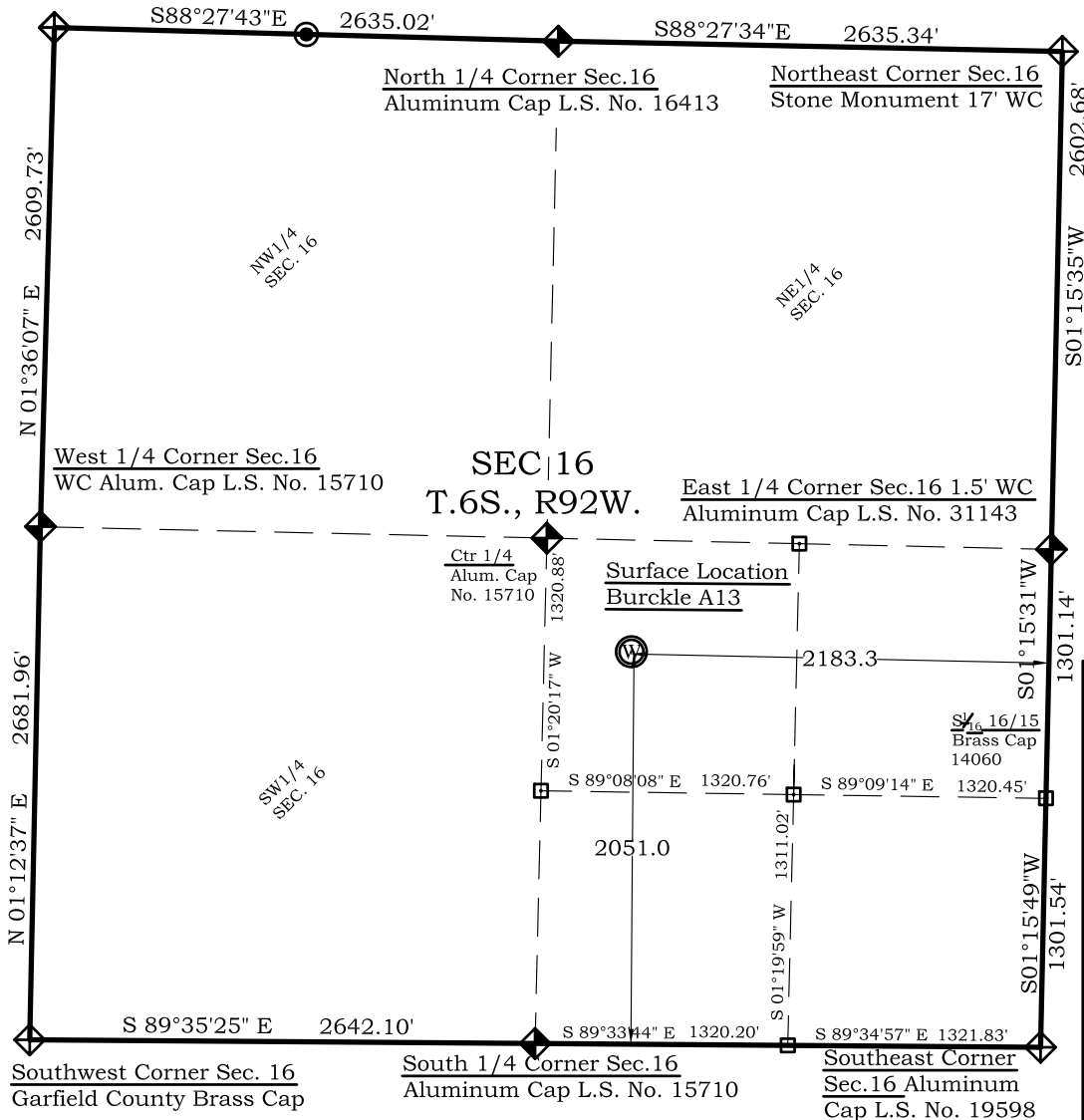


As Drilled Location Plat

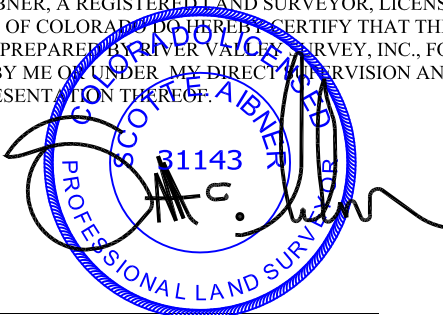
