### 15. Comments:

Static water level determined from water well permit #176203- - (Depth: 635', SWL: 325' ), located SWSW Sec. 20 T5S-R63W 6th, 714' FSL, 4830' FEL, approximately 500' SW of the location reference coordinates. This is the closest actual water well to location. The deepest water well within 1 mile is water well permit #: 2409-F-, located NWSE Sec. 29 5S 630W, ~5,054' from this well. This water well was drilled to 1864' in depth, however it was plugged and abandoned 12/15/2004. The deepest active producing water well within 1 mile is water well permit #: 153594- -, located in the NENE of the section. This well was drilled to 700' in depth. Surface casing design for this well thus meets the criteria of the Fox Hills protection area Rule 317A.b(2), as surface casing is designed to be set >50' deeper than any permitted producing water well within 1 mile. This location is in the Kiowa Bijou designated groundwater basin, thus "sensitive area" is marked "YES".
