Railroad is 2.07 +/- miles away from site. There are no visible improvements within 400 feet of site. Nearest water well is 1,552 +/- feet from site (RECEIPT: 9053342; PERMIT: 3358-F-; Domestic use). There is a creek 3,293 +/- North of the site. The location is in a sensitive area due to being within the Northern high Plains designated Basin. No COAs are needed for this location. A pump jack may be necessary to place on the facility in the future to help with gas production. It will require either one gas or electric motor to run the pumping jack unit which will be determined at the time of installation.
