RAILROAD IS 1.78 MILES AWAY FROM SITE. THERE ARE NO VISIABLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL IS 85 FEET FROM SITE (RECEIPT 0001648; PERMIT 831-AD- USE IRRIGATION) THERE IS A DRY, EPHEMERAL STREAM LOCATED 926 +/- FEET NORTH OF LOCATION. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
