


EOG RESOURCES, INC.

PROCEED IN A SOUTHERLY, THEN SOUTHWESTERLY DIRECTION FROM BRIGGSDALE, COLORADO ALONG HIGHWAY 392 APPROXIMATELY 9.7 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 74 TO THE EAST; TURN LEFT AND PROCEED IN AN EASTERLY DIRECTION APPROXIMATELY 7.1 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 83 TO THE SOUTH; TURN RIGHT AND PROCEED IN A SOUTHERLY DIRECTION APPROXIMATELY 3.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 68 TO THE EAST; TURN LEFT AND PROCEED IN AN EASTERLY DIRECTION APPROXIMATELY 3.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 89 TO THE SOUTH; TURN RIGHT AND PROCEED IN A SOUTHERLY DIRECTION APPROXIMATELY 0.1 MILES TO THE BEGINNING OF THE PROPOSED ACCESS TO THE EAST; FOLLOW ROAD FLAGS IN AN EASTERLY DIRECTION APPROXIMATELY 152' TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM BRIGGSDALE, COLORADO TO THE PROPOSED WELL LOCATION IS APPROXIMATELY 22.9 MILES.


