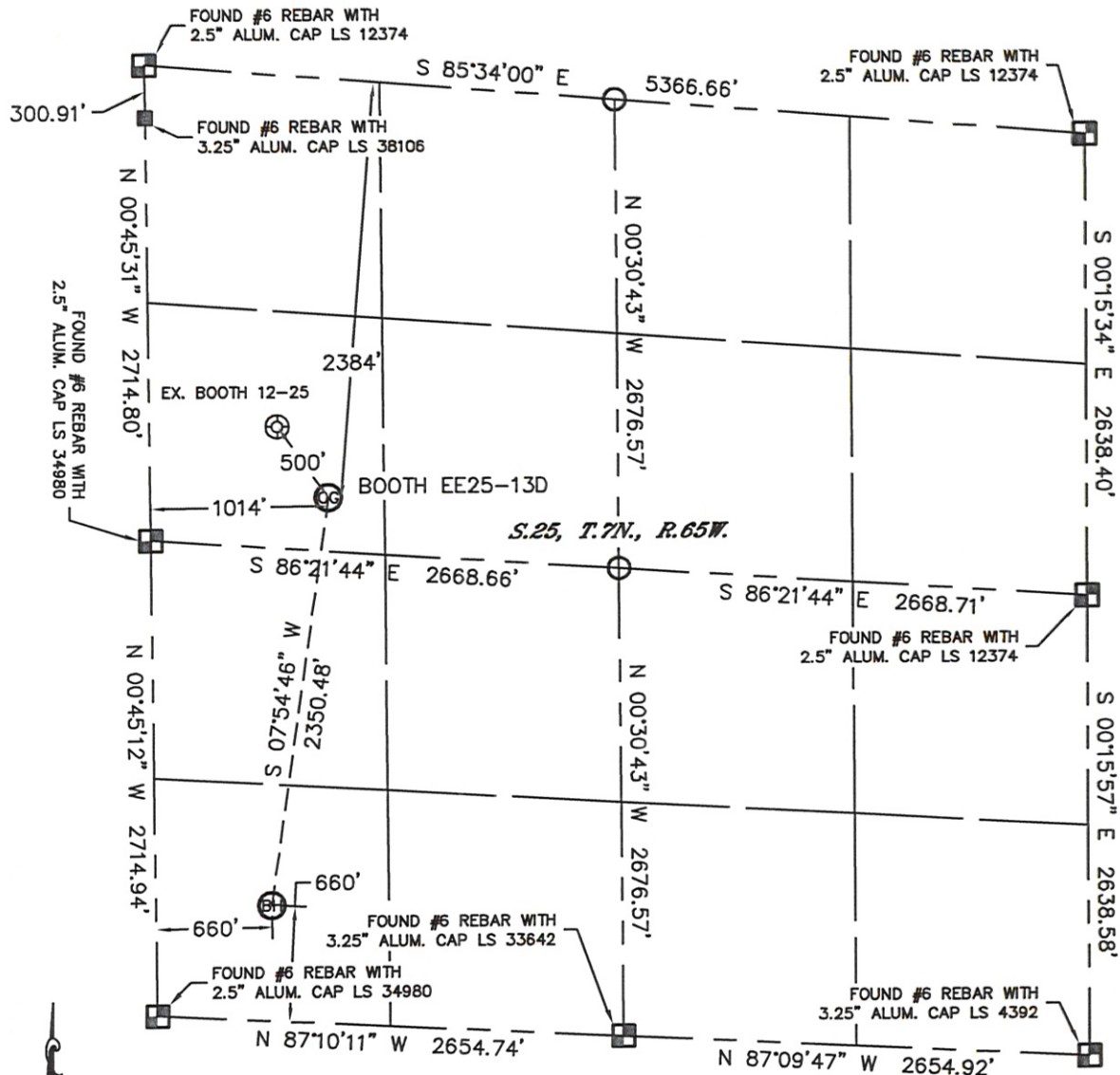


# WELL LOCATION CERTIFICATE

In accordance with a request from Matt Verbit with Noble Energy Inc. Lat40°, Inc. has determined the surface location of the BOOTH EE25-13D to be 2384' from the NORTH line and 1014' from the WEST line and the bottom hole to be 660' from the SOUTH line and 660' from the WEST line as measured at right angles from the section lines of Section 25, Township 7 North, Range 65 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 6/10/11, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

- 1) Bearings shown are Grid Bearings of the Colorado State Plane Coordinate System, North Zone, North American Datum 1983/2007. The lineal dimensions as contained herein are based upon the "U.S. Survey Foot."

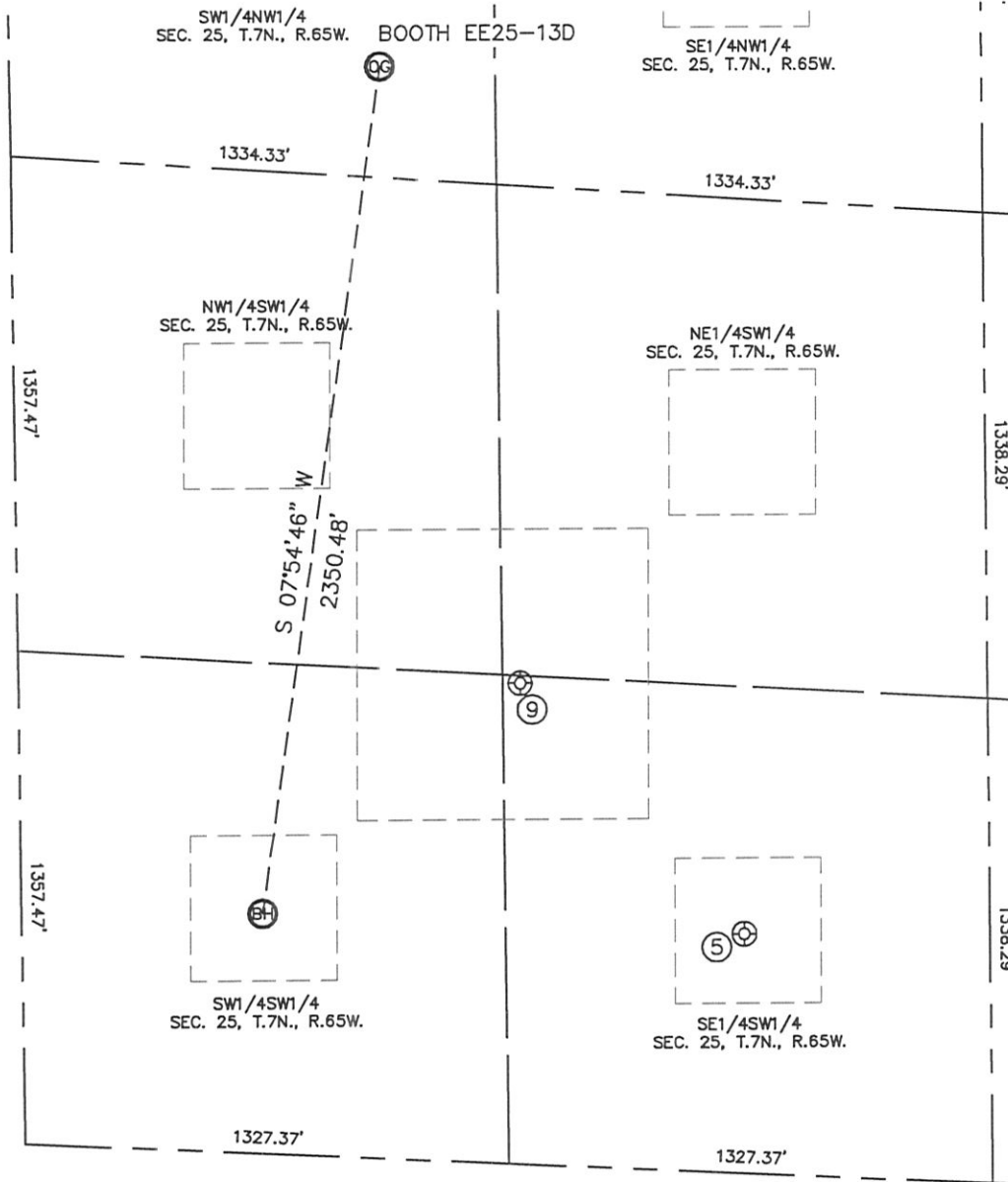
