RAILROAD IS 2.59 MILES AWAY FROM SITE. THERE ARE NO VISABLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL IS 1850 +/- FEET FROM SITE ( RECEIPT 0040999, PERMIT 3708-AD- USE DOMESTIC). THERE IS A DRY EPHERMERAL STREAM LOCATED 237 FEET FROM LOCATION. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
