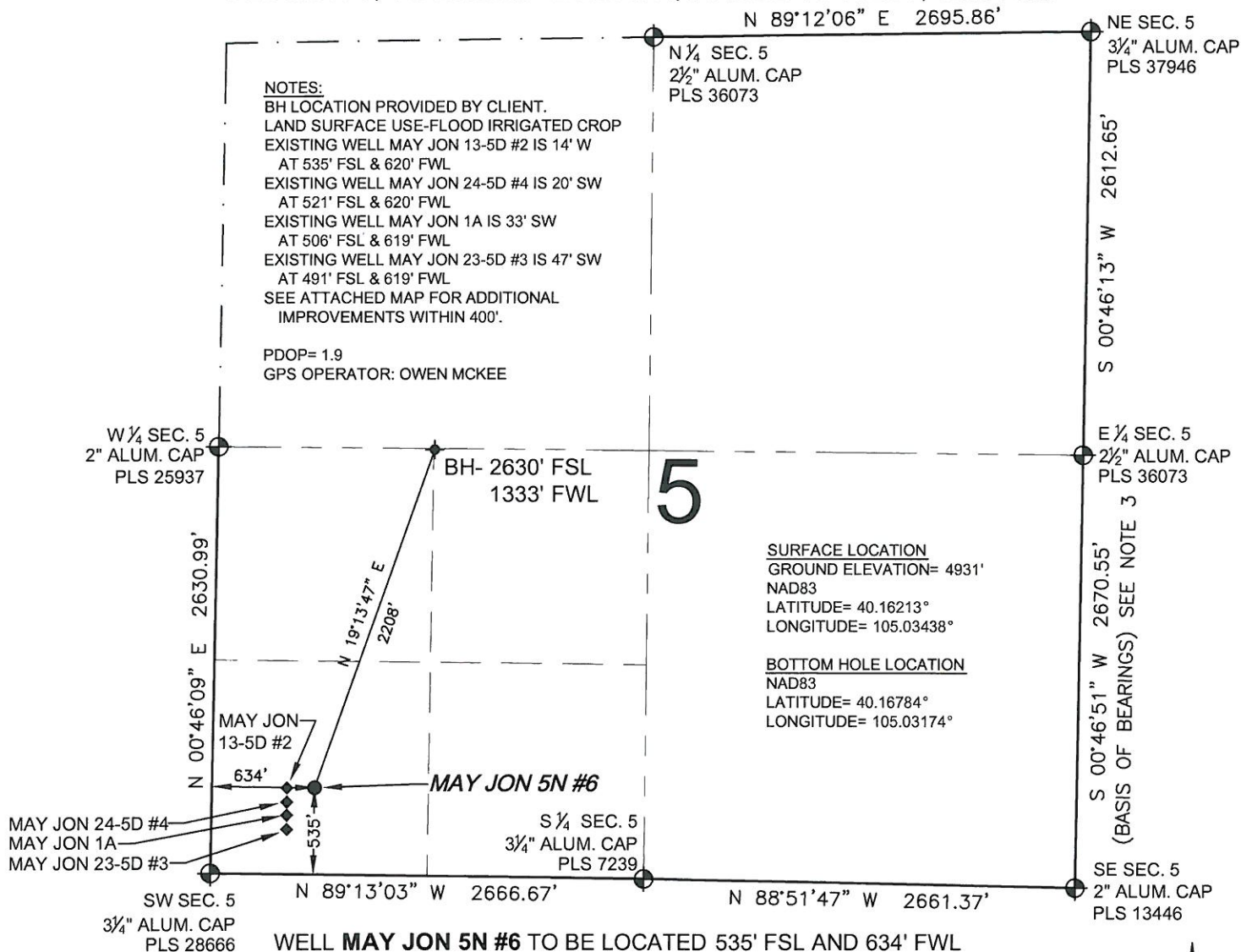


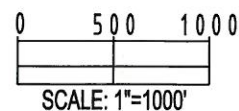
WELL LOCATION CERTIFICATE: MAY JON 5N #6

● = PROPOSED WELL ◆ = EXISTING WELL

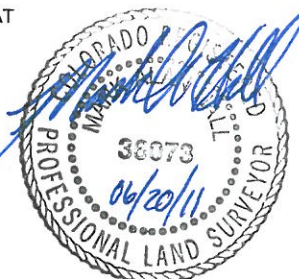
