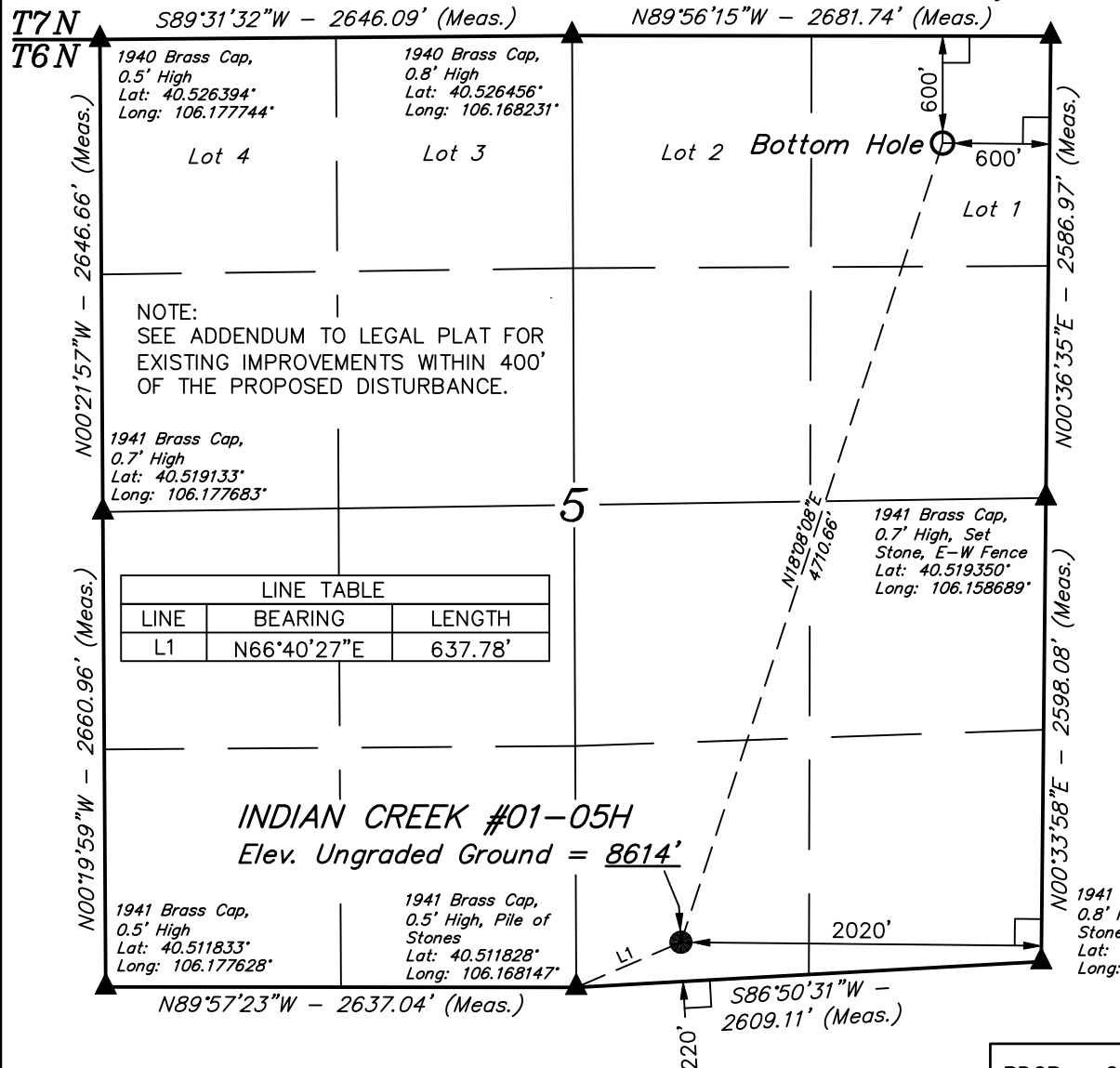

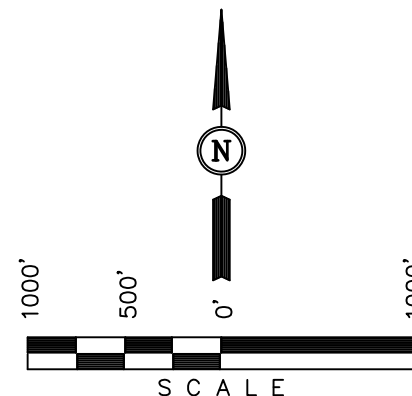


BASIS OF ELEVATION
