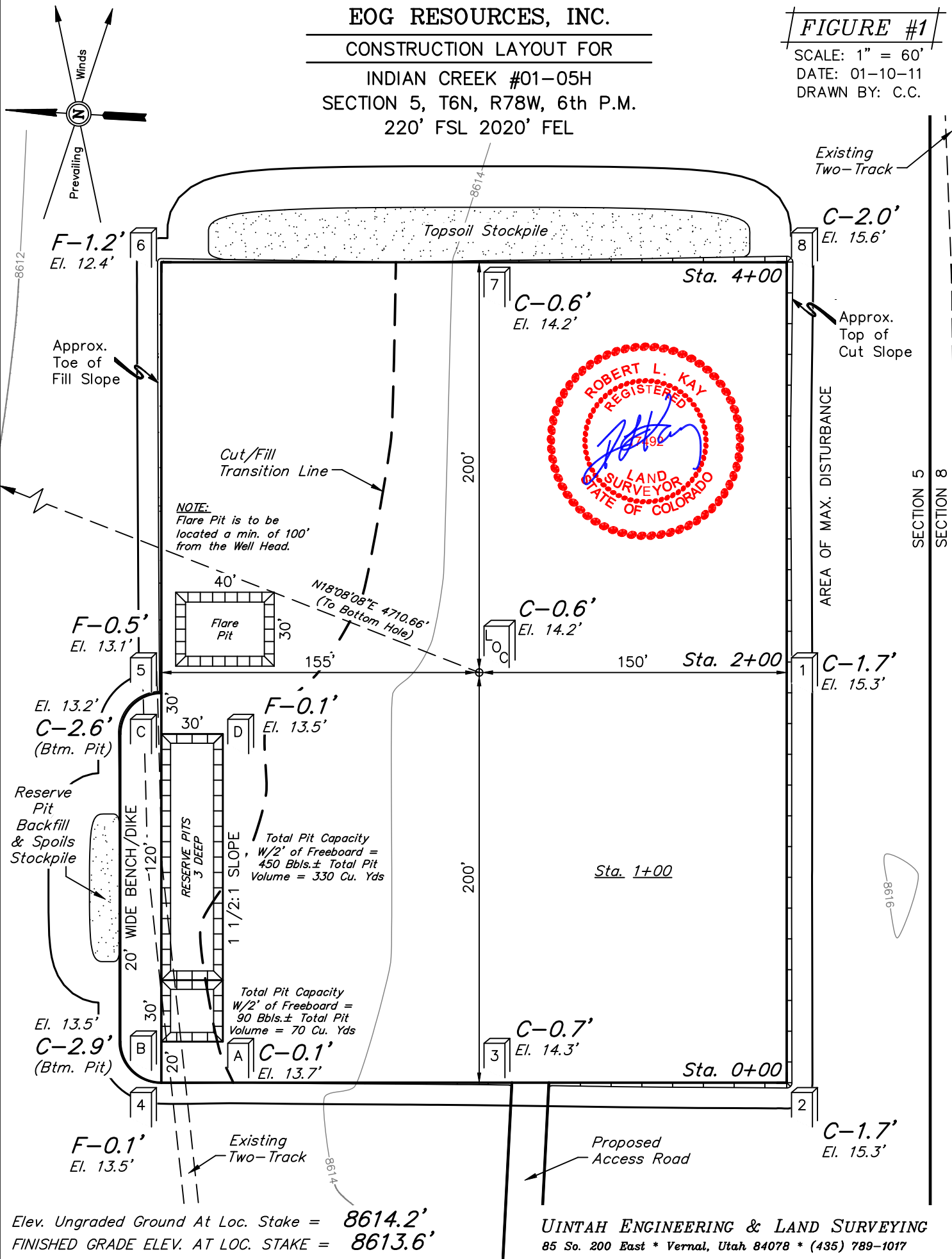

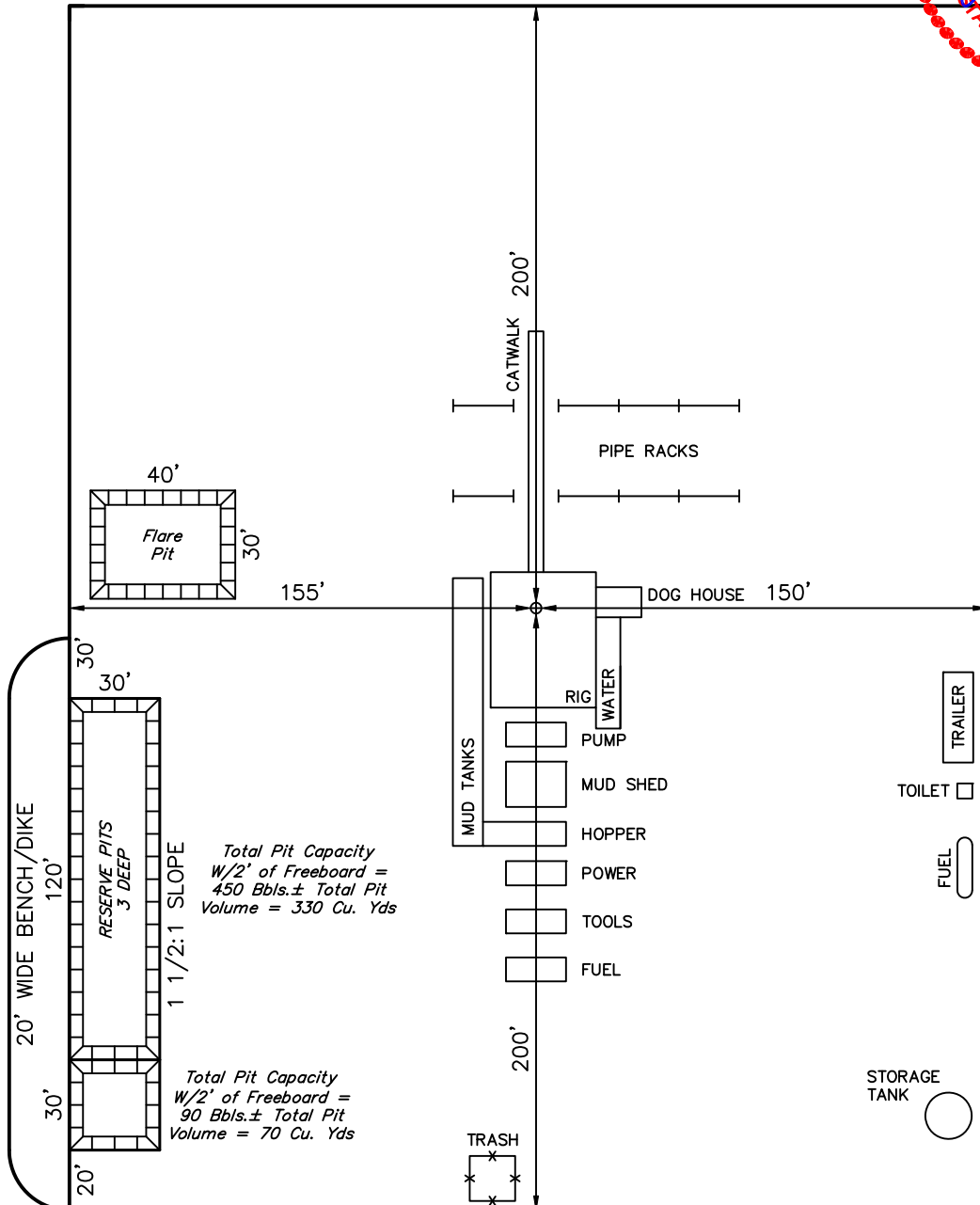

Access Road

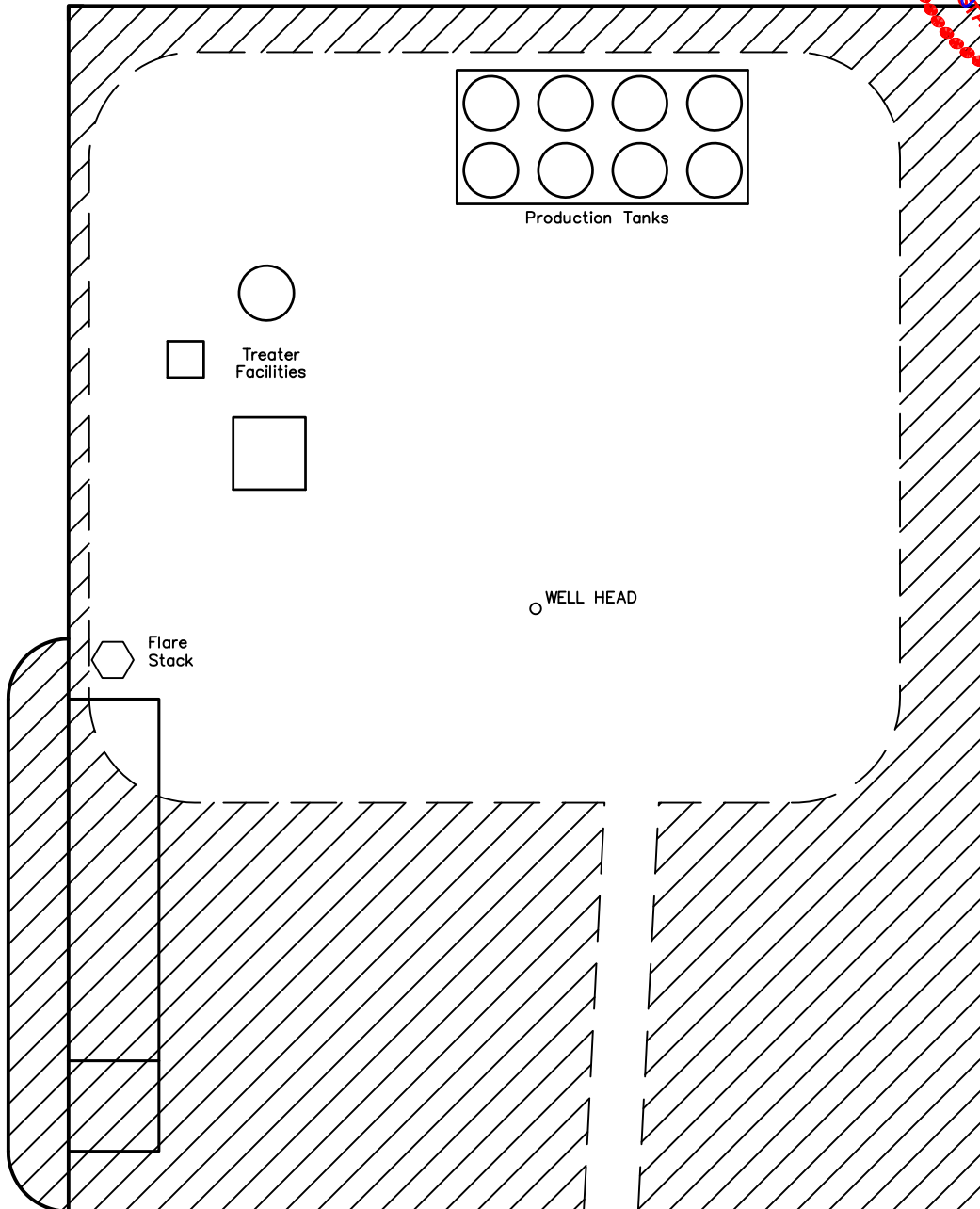

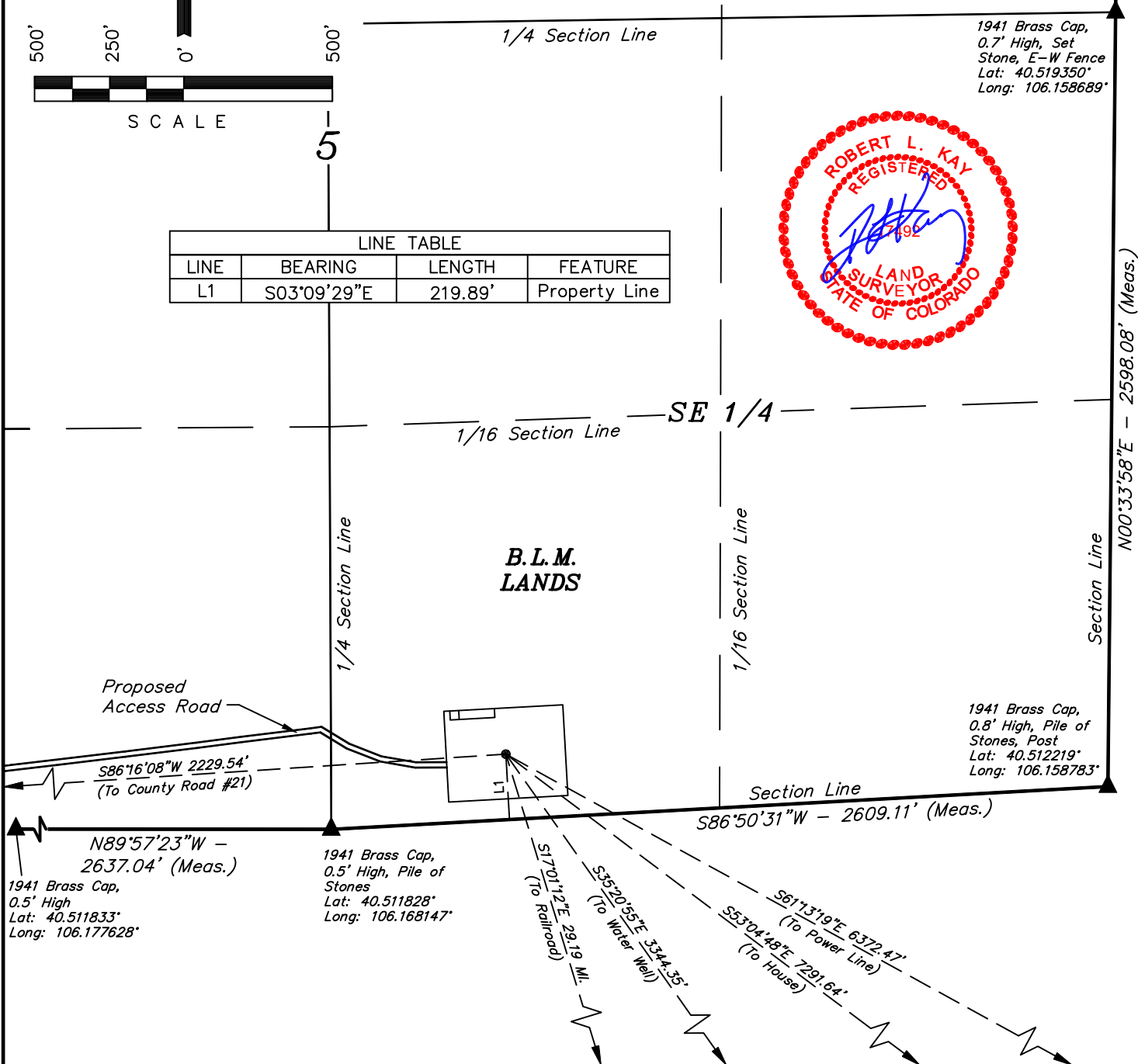
