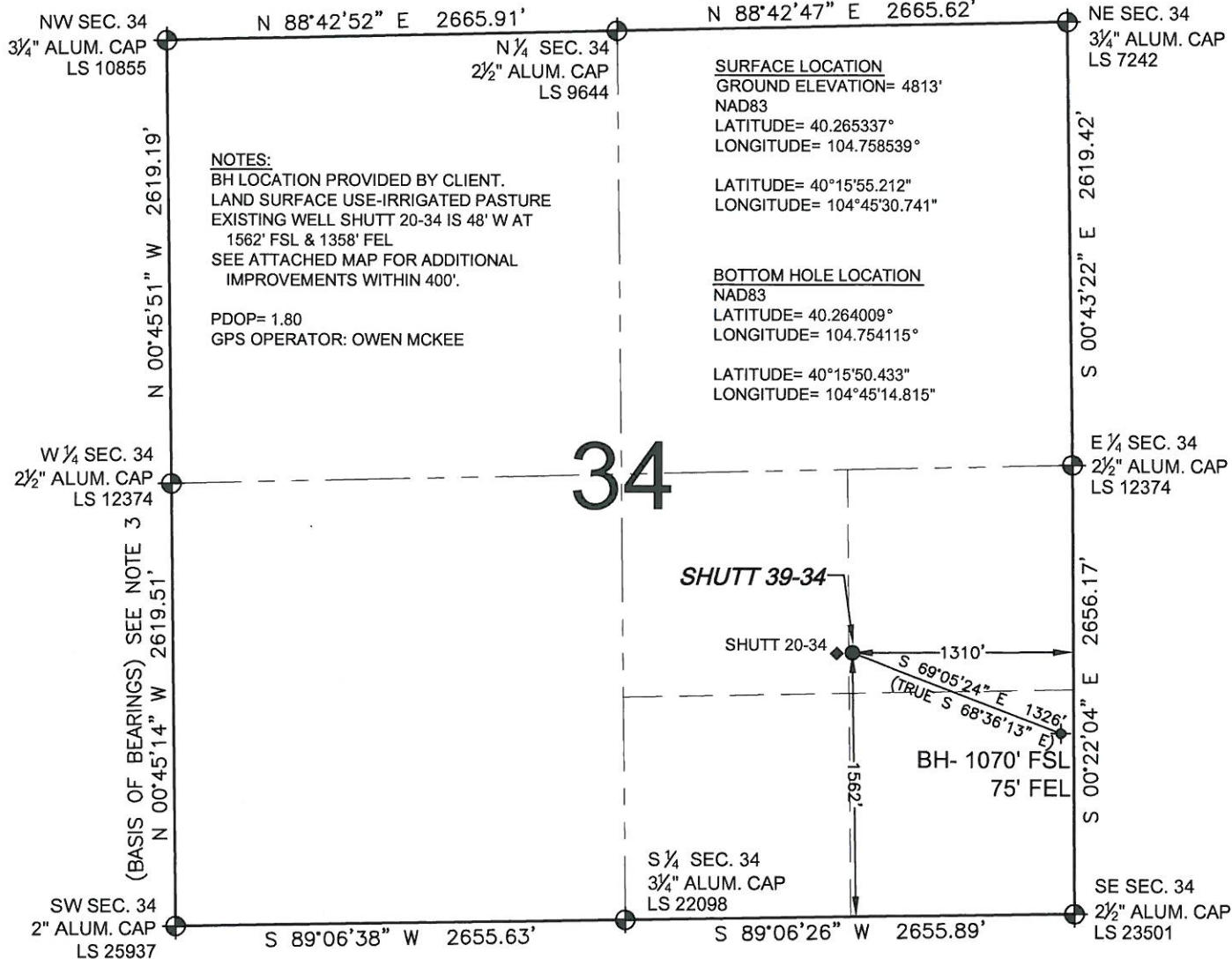


WELL LOCATION CERTIFICATE: SHUTT 39-34

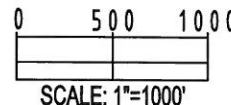
SECTION 34, TOWNSHIP 4 NORTH, RANGE 66 WEST, 6TH P.M.

● = PROPOSED WELL ♦ = EXISTING WELL

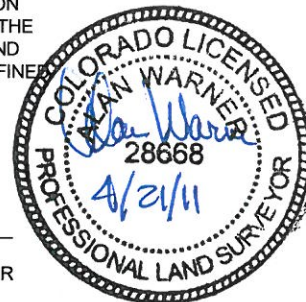
