Railroad is 4.37 +/- miles away from site. There are no visible improvements within 400 feet of the site. Nearest water well is 2003 feet from site (Receipt; 0071546E, Permit; 21440.F, use irrigation). There is a dry intermittent stream 1449 feet +/- from site. This location is in a sensitive area due to being within the Northern High Plains Designated Basin. NO COAS are needed for this location. A pump jack may be necessary in the future to help with gas production. It will require either one gas motor or one electric motor to run the pumping unit.
