RAILROAD IS 2.28 MILES +/- AWAY FROM SITE. THERE ARE NO VISABLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL 2066 +/- FEET FROM SITE (RECEIPT: 9053926 PERMIT:43015 USE:DOMESTIC) THERE IS A CREEK 502 FEET WEST OF LOCATION. THE LOCATION IS IN SENSITIVE AREA DUE TO BEING WITHIN THE NORHTERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
