NEAREST WATER WELL 952 +/- FEET FROM SITE (RECEIPT; 9054506, PERMIT; 15318-FP, USE; DOMESTIC) THERE IS A RAIN FILLED LOW SPOT 20 FEET AWAY AND AM INTERMITTENT POND 1628 FEET TO THE NORTH OF SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA,S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO HELP WITH GAS PRODUCTION.IT WILL REQUIRE EITHER ONE GAS OR ELECTRIC MOTOR TO RUN THE PUMPING UNIT WHICH WILL BE DETERMONED AT THE TIME OF INSTALLATION.
