Railroad is 2.04 +/- miles from site. There is a building approximately 389 feet from the site. Nearest water well is 1977 +/- feet from site (Receipt: 9054192, Permit; 146748, Use Domestic). There is an intermittent creek 4984 feet to the north. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for this location. A pump jack may be necessary to place on the facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping unit which will be determined at the time of installation.
