Railroad is 2.21 +/- miles from site. There are no visible improvements within 4000 feet of site. Nearest water well is 1810 +/- feet from site (Receipt; 9053926, Permit; 43015. Use - Domestic). There is an ephemeral creek 20 feet north of the site. The location is in a sensitive area due to being with the Northern High Plains Designated Basin. No COA's are needed for this location. It may be necessary to place a pump jack on the location to aid the gas production. It will require either one gas or one electric motor to run the pumping unit which will be determined at the time of installation.
