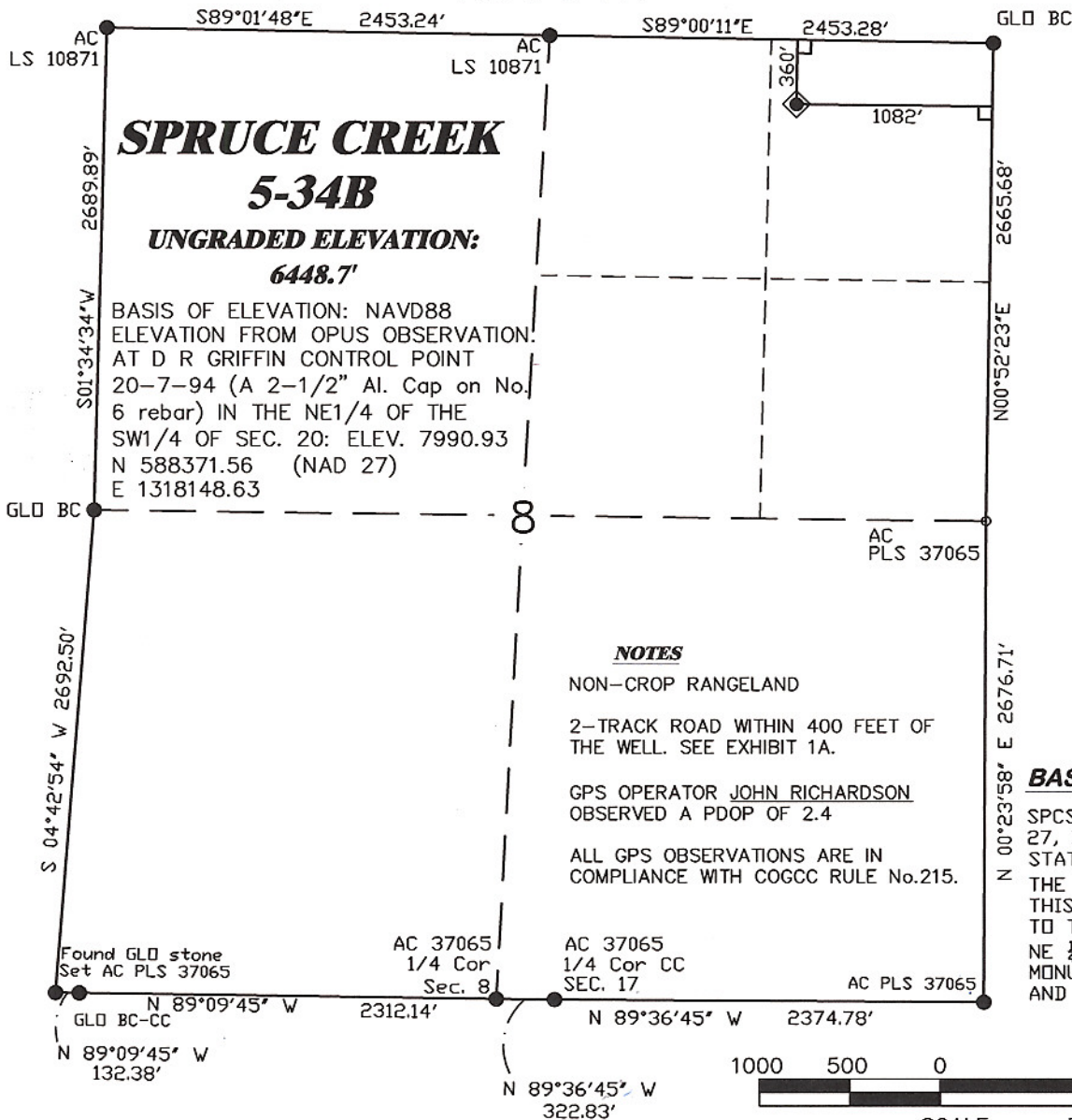

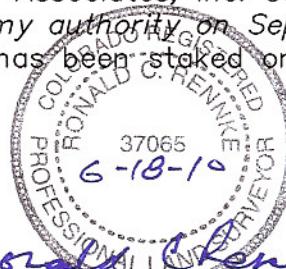

FOR NOBLE ENERGY, INC.**

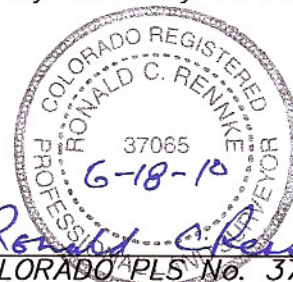
