RAILROAD IS 2.53 +/- MILES AWAY FROM SITE. THERE ARE NO VISABLE IMPROVEMENTS WITHIN 400 SITE EXCEPT AN EXISTING EPHERMERAL STREAM. NEAREST WATER WELL 1094 +/- FEET FROM SITE (RECEIPT 9053926, PERMIT 43015; USE DOMESTIC). THERE IS A EPHERMERAL STREAM LOCATED 363 FEET FROM LOCATION. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA 'S ARE NEEDED FOR THIS LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH THE GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
