### 15. Comments:

Nearest building is a pump house for the Adena Unit water injection system. Nearest above ground utility is the power line to the R.Y. Davis #1 well. Nearest railroad is in Fort Morgan. Nearest surface water is a seasonal pond that is southwest of the battery and can be seen on the access road map. The nearest water well (receipt #0317634, permit #1328--A) does not have a reported ground water level, so depth to ground water (20') is from a water well (receipt #9046094, permit #1328) that is 1900' from the Davis Battery. The reclamation reference area is immediately adjacent to and west of the planned facility. Location reference point is the center of the north oil tank.
