THERE IS AN EPHEMERAL CREEK 3670 +/- FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITH THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMP JACK ON THE FACILITY AT SOME POINT IN THE FUTURE TO HELP WITH THE GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ELECTRIC MOTOR TO RUN THE PUMPING UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
