COA 1: The fresh water storage pit shall include signage that: identifies the pit use as a freshwater-only pit, prohibits placing E&P Waste in the pit, and lists each well that the pit will serve.

COA 2: Operator is prohibited from allowing any fluids to flow back to the fresh water Frac Pit.

COA 3: The freshwater storage pit shall be constructed and maintained to prevent terrestrial wildlife or livestock entrapment.

COA 4: Notify COGCC OGLA Specialist Rick Allison at rick.allison@state.co.us 48 hours prior to construction of the frac reserve pit.
