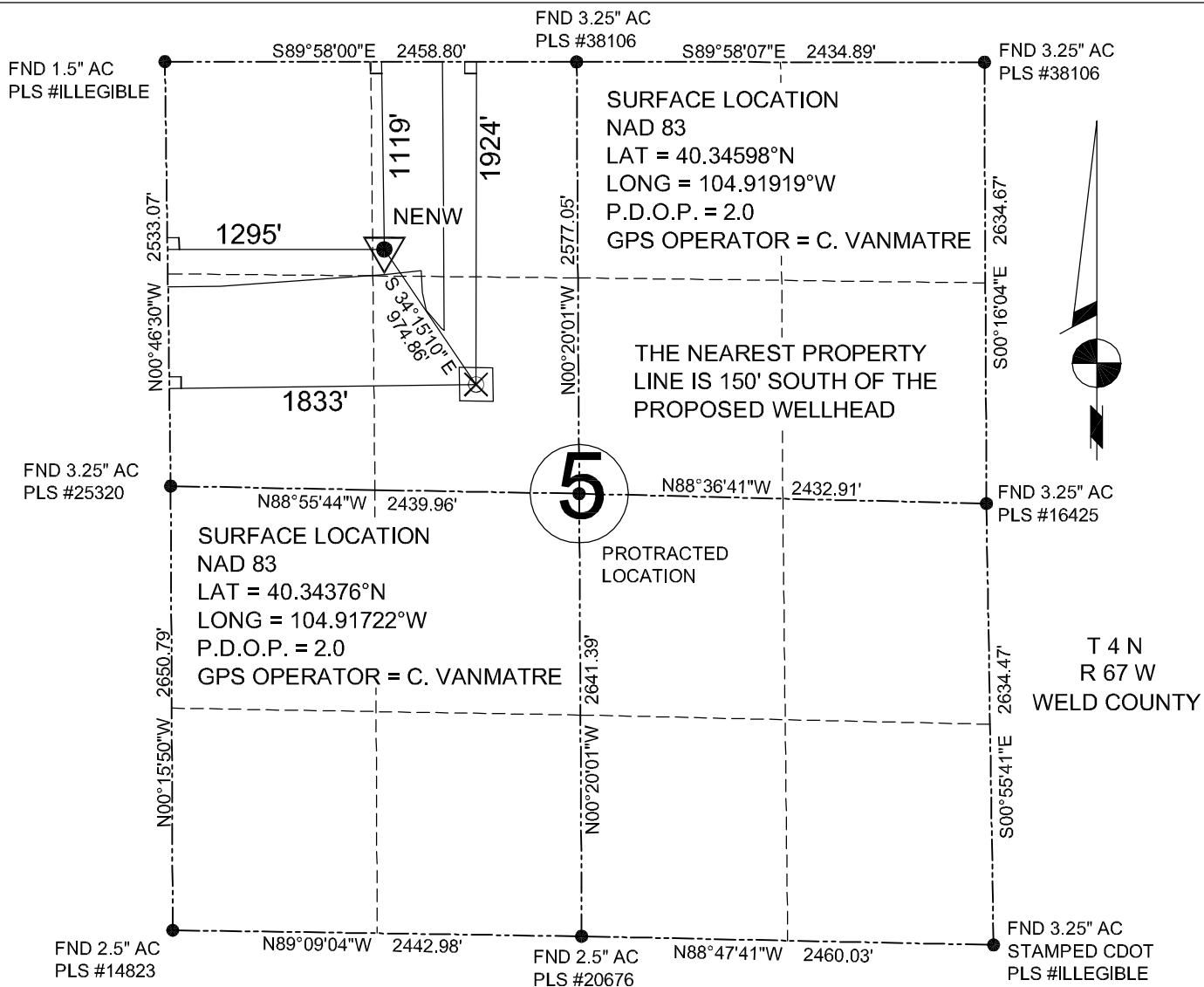


BASIS OF BEARINGS:

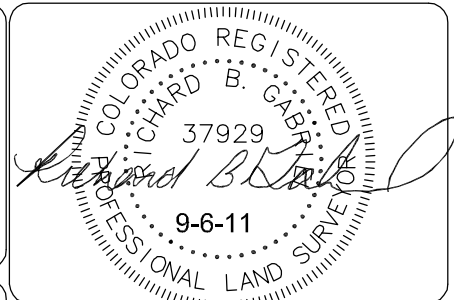
