Issue: Line # 24 and #25 should have values.

Issue: I couldn't locate the PDOP that was supplied on line # 14, which is generally stated on the Plat.

Issue: in the Objective Formation tab I have removed the Spacing Order Num(s), Unit acreage and unit configuration for the Honaker Trail as it is Rule 318a.

Issue: Line # 15 as this is a vertical well the top of production should not have information insert there.

Please review and supply the information for the first 2 issues and if you agree with the last two issues give me the authorization to change on the form.
