The COGCC is reviewing the Form 2A (#400206576) for DeBussy 24-29 location, located in the SESW Sec 29 T33S R66W Las Animas County, Colorado. The COGCC requests the following changes regarding the data submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment (OGLA).

1. Sensitive area: Due to the Lorencito-Rombo-Sarcillo Complex, 25 to 65% slopes soil type the site should be considered a sensitive area.
 - The sensitive area tab should be changed to YES.
2. **Conditions of Approval:** The following conditions of approval (COAs) will apply to the DeBussy 24-29 location:
 - Prior to putting a production pit into service Pioneer shall submit an Earthen Pit Report/Permit Form 15 to the Director for approval in accordance with rule 903.a.. No fluids shall be placed in a pit without a pre-approved form 15.
 - Location is in a sensitive area because of potential for adverse impacts to ground water/surface water; therefore all pits will be lined.
 - Reference area pictures shall be provided to the COGCC within 12 months of approval of the form 2A.

- Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to keep a release of drilling, completion, produced fluids, or chemical products from migrating off the oil and gas location.
