Linda,

Thanks for your quick response on this.

1. I specifically told our consultant not to make a site-specific map for that date because we only had one data point and as a result the gradient across that pad is largely extrapolation even when paired with the RWF 342-22 location. But if you would like to see that, I'll have Olsson create a zoomed in version of the original map from June.
2. I did not understand the request to be retroactive as we did not have a specific water disposition plan in place for the historic events – particularly with respect to rads or associated metals. However, I will ask Olsson to update the text to include a brief description of what was done for the two sampling events in question.

I'll try to get you something early next week.

Gretchen,

Thanks for addressing two of the four items that I requested. However, two items I requested are not complete in this version.

1. Potentiometric maps, localized to the RWF 33-22 well pad area, for each date of water level collections.

1. I would like to see groundwater potentiometric maps for both the June 2010 and August 2010 sampling events. Both figures should be of same scale, focusing on the well pad site, like the figure you did include. I realize that you only had the DOE wells and the wells on the RWF 342-22 well pad to generate a June 2010 potentiometric map. A footnote on the map noting that the diagram is a subset of a regional potentiometric map should explain why there is only one data point on the diagram to support the contours for the June 2010 figure.

2. Include a section on disposition of purge water from sampling of all monitoring wells, for every sampling event.

1. I do not see a discussion of where purge water went during the June 2010 and August 2010 sampling events. I only see a proposed drumming of purge water discussion for future sampling events.

Please revise to include these items.
