Static water level determined from Permit #: 78833- -, located 340' FNL, 89' FWL, NWNW Sec. 2, T6N-R63W, ~ 925' southeast of the proposed well. This water well is the closest one to the location. It was drilled to a depth of 200'. The deepest water well within 1 mile, Permit #: 194743- -A located SWSW Sec. 35, T7N-R63W, was drilled to a depth of 300'.
