Thanks for sending the requested information. I have reviewed the documents on behalf of Linda Spry.

- **Hells Gulch Federal 23-13A (REM # 4455)** will be closed. No further action (NFA) is required. I will send you a letter for your files.
- **Hawkins Ranch 10--7 (REM # 4453):** Please go ahead and proceed with the sampling, and submit the results by November 30, 2011 with a new Form 27 (please use REM # 4453 as reference). The new Form 27 will either recommend soil remediation or request NFA. The storm water protection riprap needs to be inspected and maintained if necessary. Please include the riprap evaluation in the Form 27.
- **Hawkins Ranch 10-4 and 10-2C (Tracking # 1984975):** Form 27 will be entered, approved, and then closed. No further action (NFA) is required. I will send you a letter for your files.
