Enclosed are copies of the following documents to assist you in your review and approval of NEI's proposed APD for the captioned well:

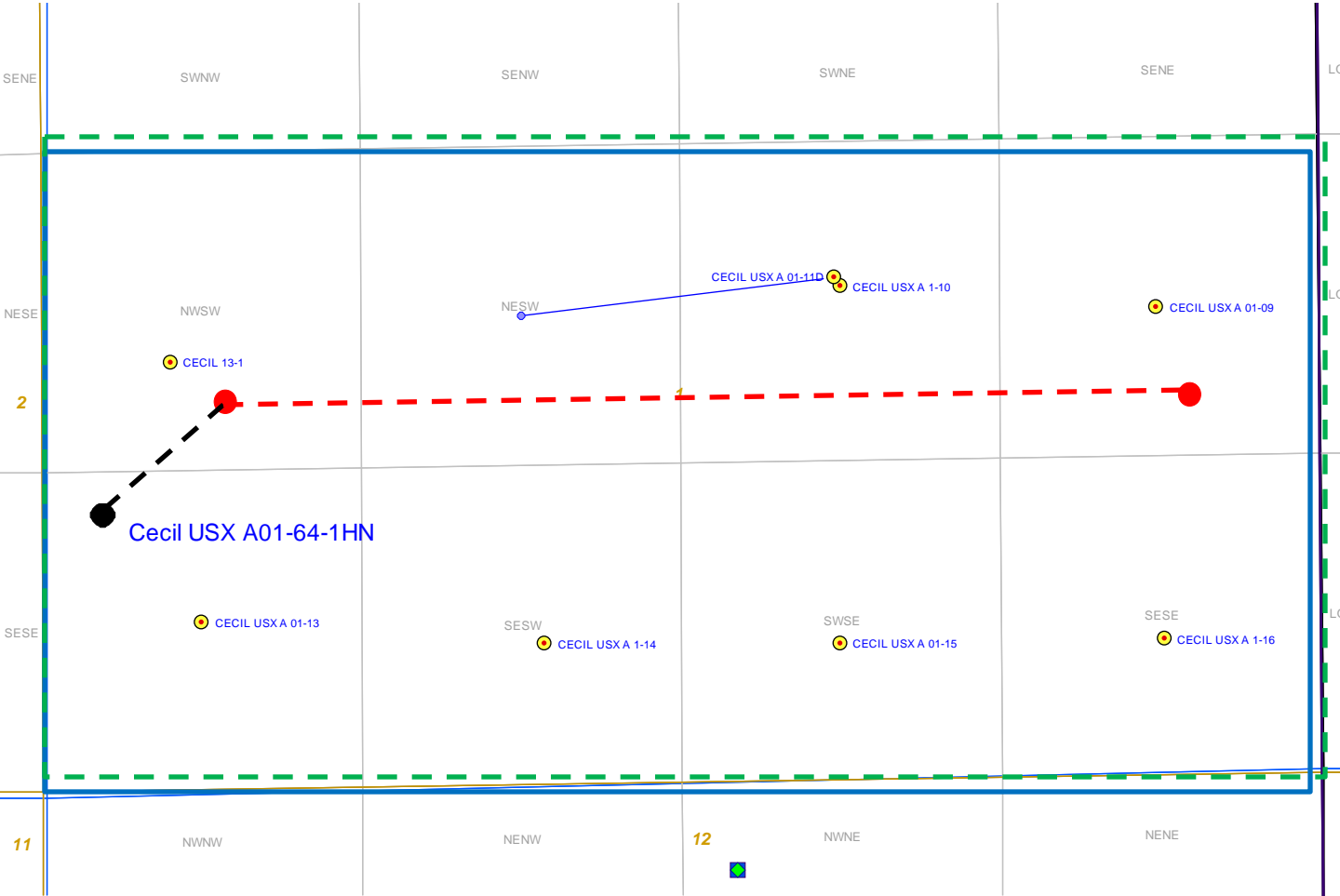

Bottom Hole Location

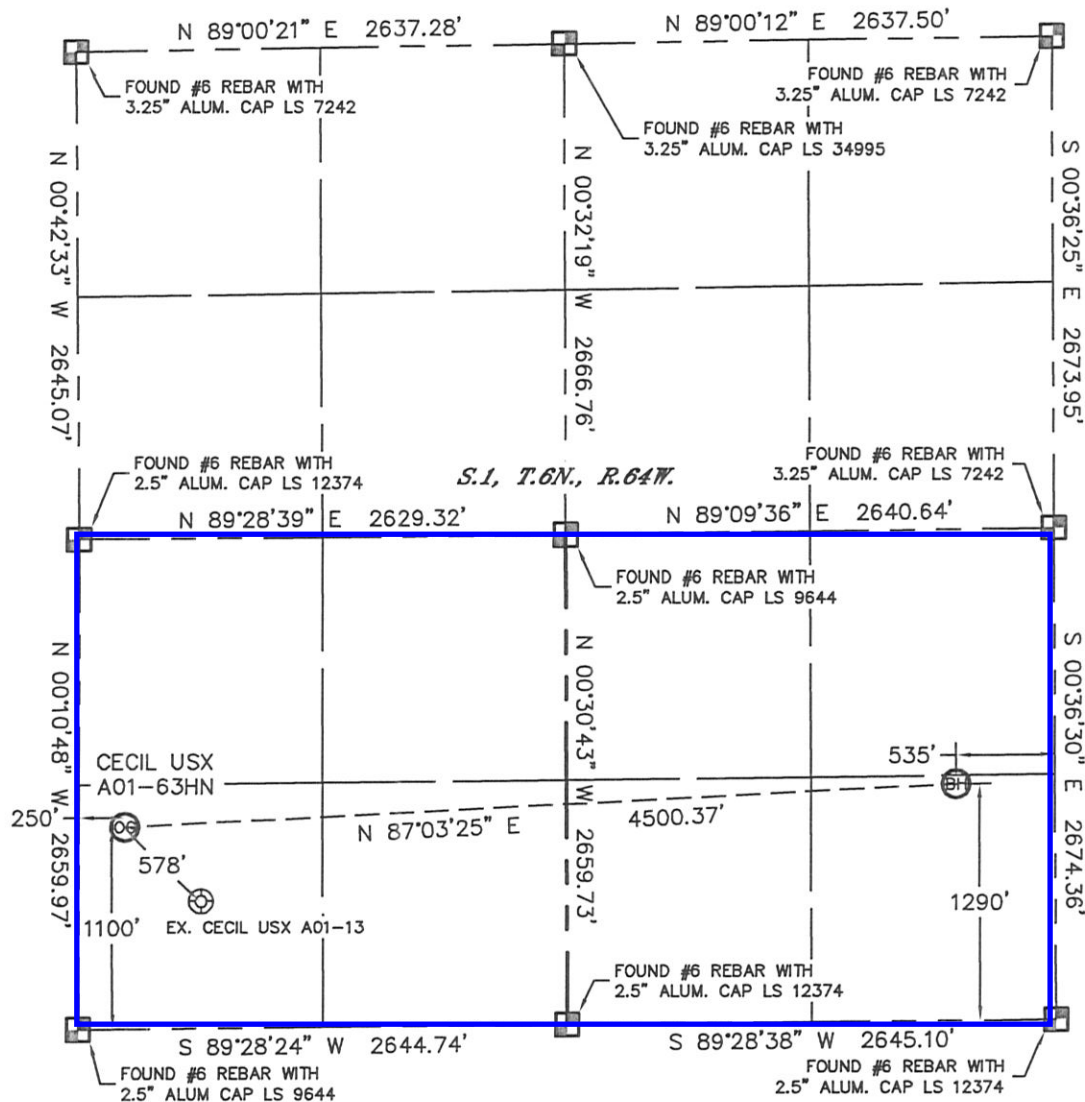


Bottom Hole Located S/2, Sec. 1, T6N, R64W

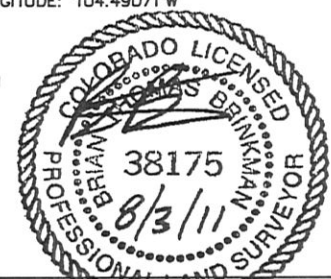
