13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Kinder Morgan would like to reenter this well for the purpose of using it as a monitor well for bottom hole pressure readings. This information would be used to indicate any separation in the Leadville caused by geological faults between the east and west sides, (seperated by the Dolores River), of the Doe Canyon Unit. The pressure on the east side would be compared to known pressures on the west side to see if there is communication in the formation. This P&A was subsurface and surveyors were used along with metal detectors to get a fairly good locate but some digging may be necessary to fine the precise location being this area is in an un-subdivided survey area. The well location reclamation is all grass and some wild flowers and there are no trees in the area. Impact would be minimal as only a workover rig would be deployed and area is flat surface where no or very minimal dirt work would needed. Cuttings would be held in a steel tank and being transported off location for disposal. Access road is all in good condition and still has a gravel surface. Readings would be taken on a quarterly or bi-yearly time frame where wire line would be used.

We would hope to be able to start this work during early August 2011.
