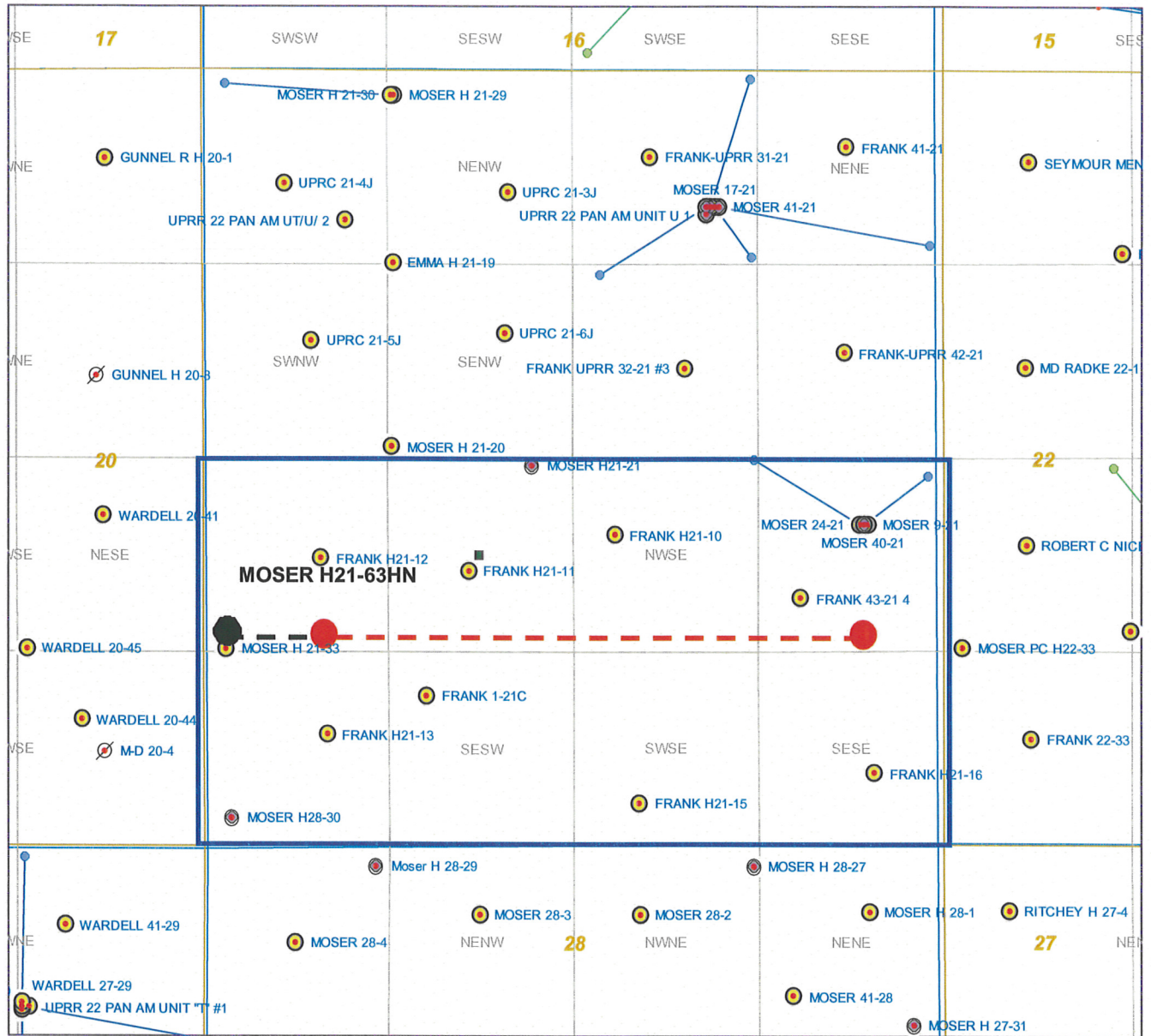

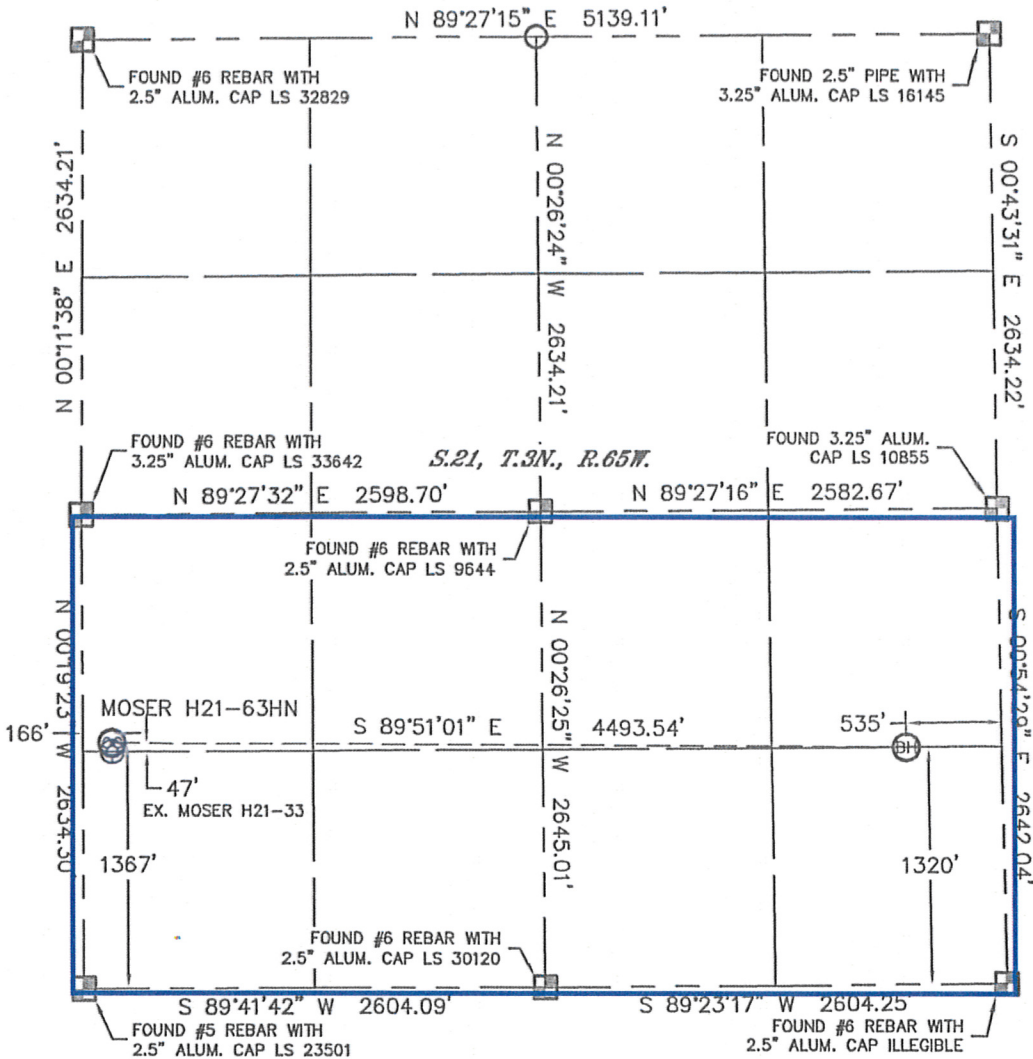
Proposed 320 acre spacing unit

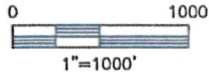

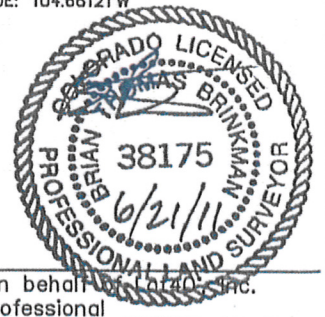
