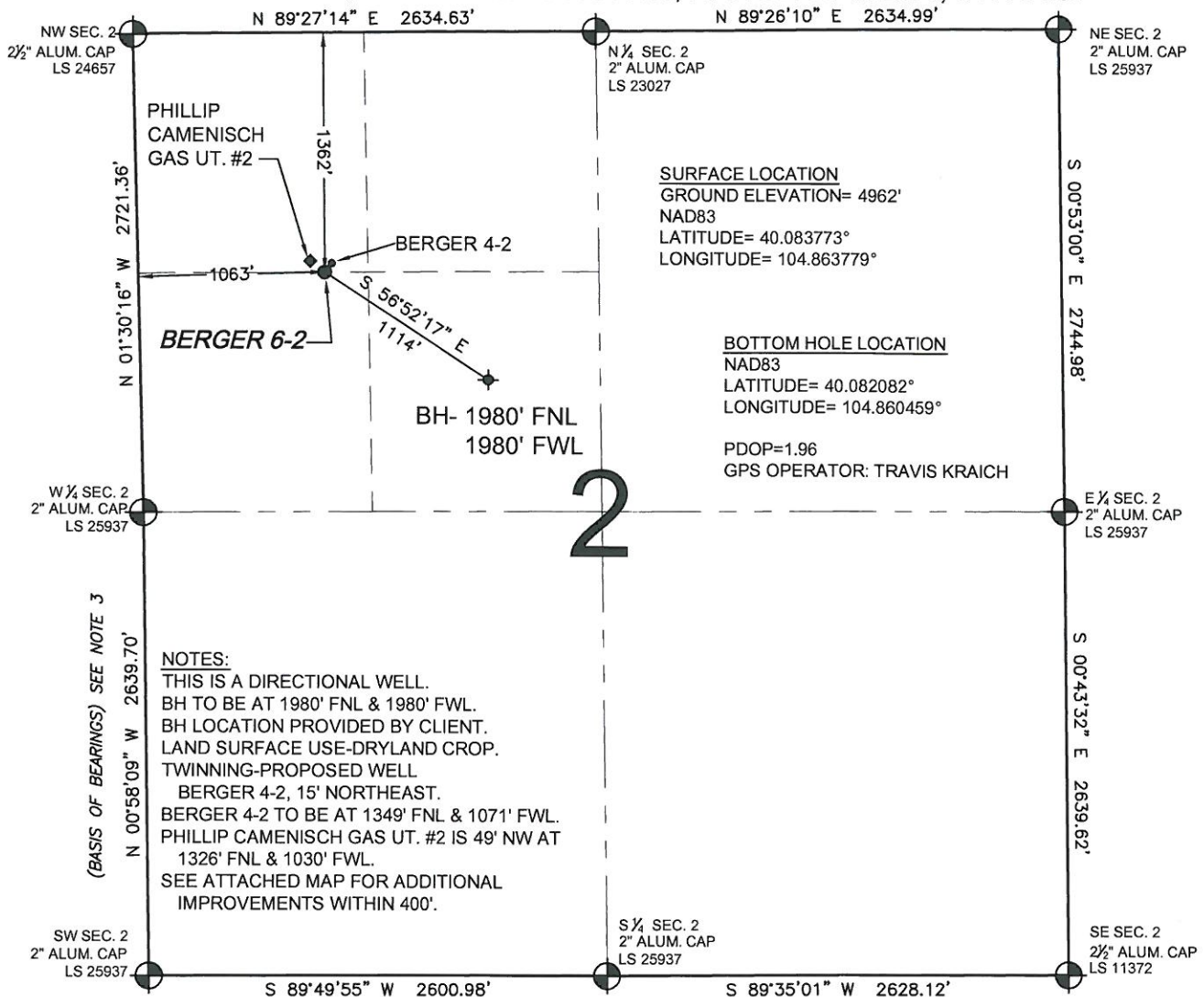


WELL LOCATION CERTIFICATE: BERGER 6-2

SECTION 2, TOWNSHIP 1 NORTH, RANGE 67 WEST, 6TH P.M.



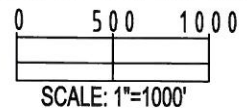
