Colorado Oil and Gas Conservation Commission (COGCC) staff has reviewed the

information you submitted on October 10, 2011 for the referenced site. Based on review of data presented, it appears that no further action is necessary at this time at this site. However, should future conditions at the site be discovered of contaminant concentrations in soils exceeding COGCC standards or if groundwater is found to be significantly impacted, COGCC may require that further investigation and/or remediation be conducted.

Per our conversation a couple of weeks ago, I have attached a memo addressed to the BLM requesting access to their land. The memo also provides as an update to the offsite portion of the approved Phase II workplan submitted the fall of last year. There are no real changes to what is already approved, but details specifically the proposed monitoring well locations. We are currently scheduled to proceed with the offsite monitoring well installation next Monday.

In addition to providing the Phase II update, I have also attached a letter with Form 4 requesting permission to decommission the landfarm at Federal 23-12. Stantec is seeking approval from both the BLM and COGCC for this action. Please let me know if the COGCC approves. I will be sending this request to the BLM separately.
