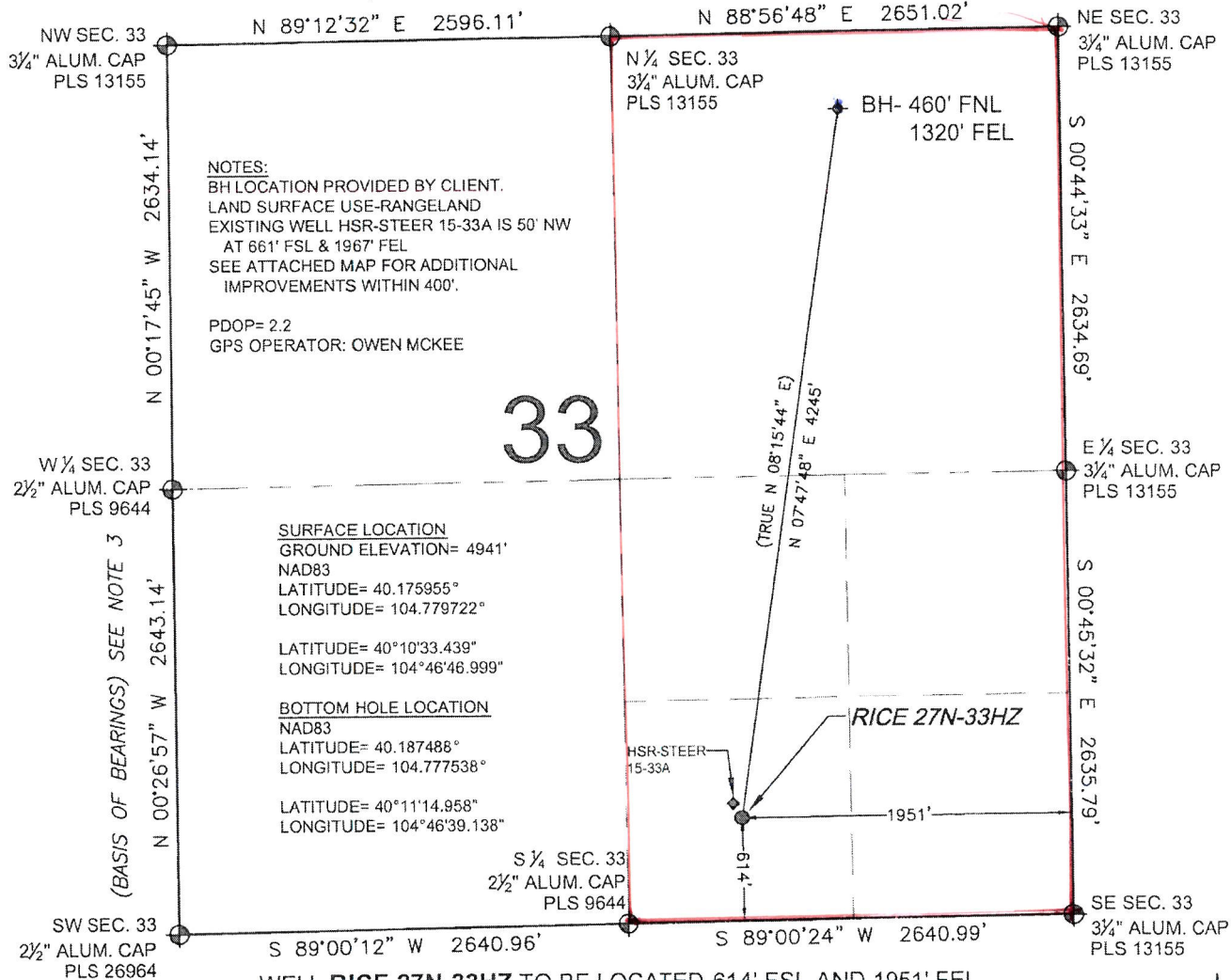

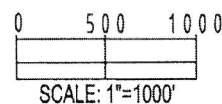
WELL LOCATION CERTIFICATE: RICE 27N-33HZ
