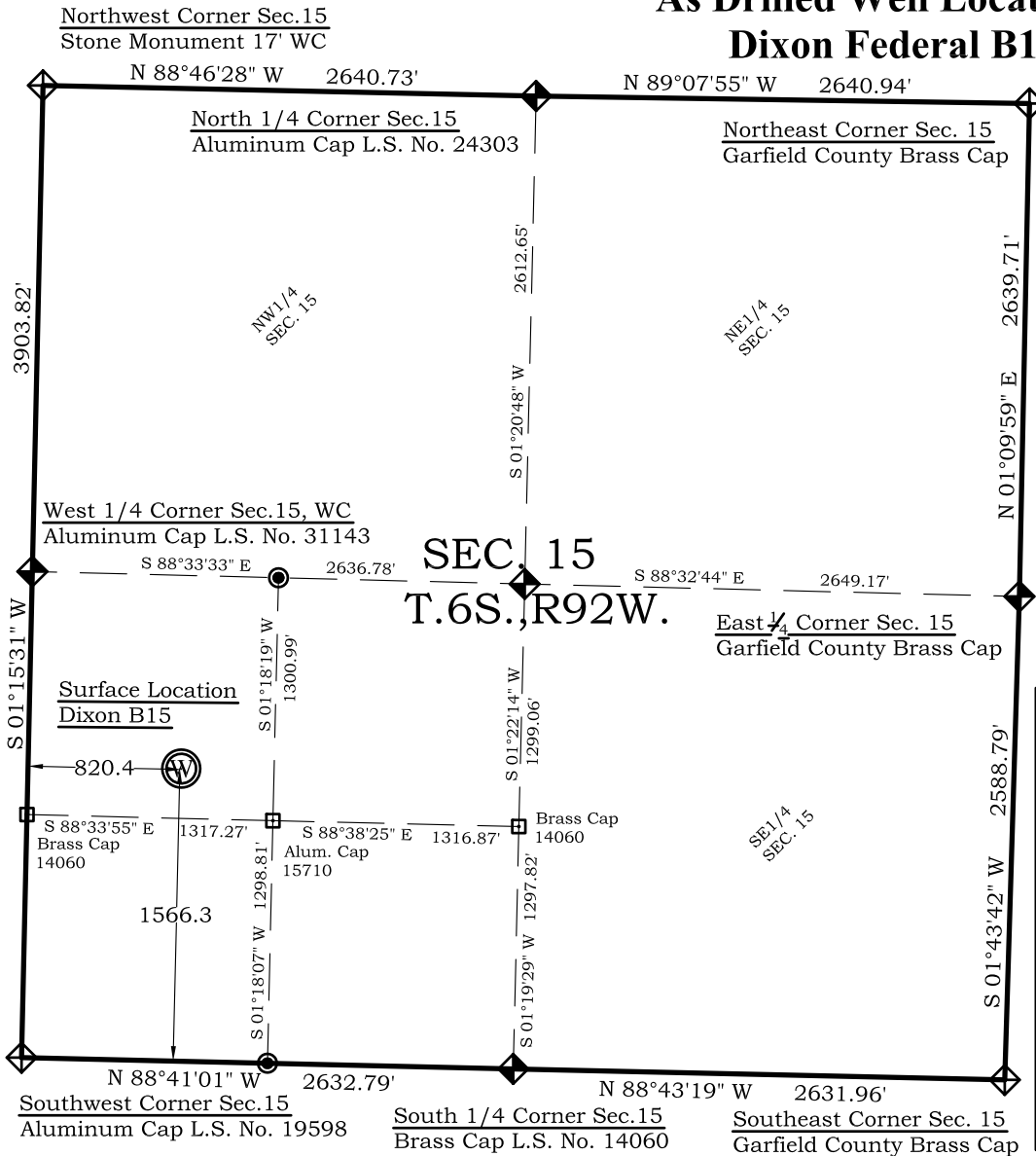


As Drilled Well Location Plat Dixon Federal B15

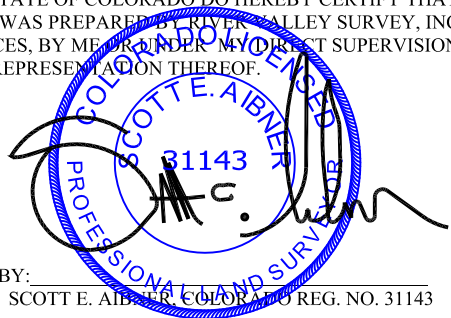
