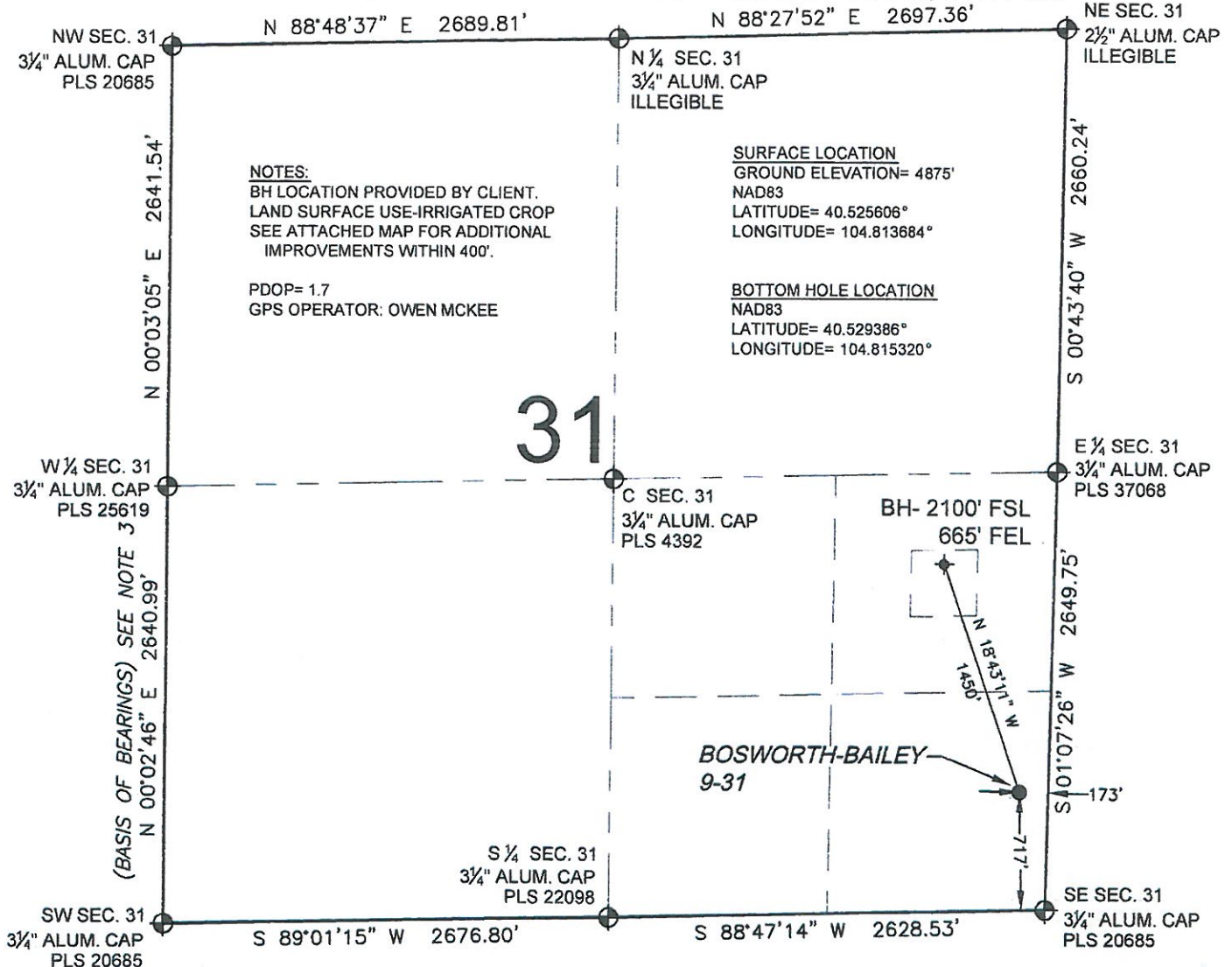


WELL LOCATION CERTIFICATE: BOSWORTH-BAILEY 9-31

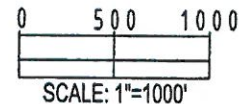
SECTION 31, TOWNSHIP 7 NORTH, RANGE 66 WEST, 6TH P.M.
