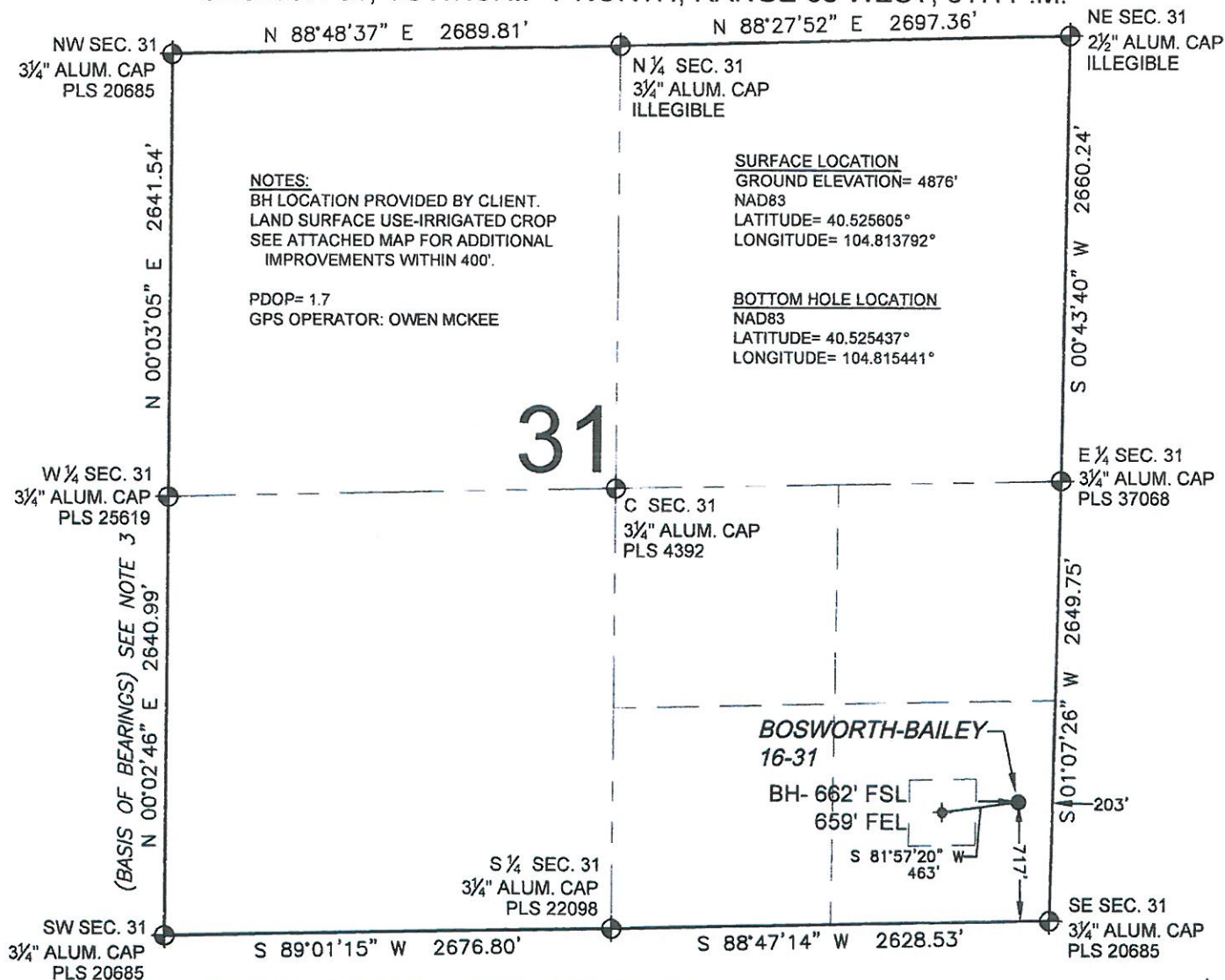


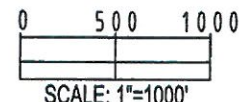
WELL LOCATION CERTIFICATE: BOSWORTH-BAILEY 16-31

- ◆ = EXISTING WELL

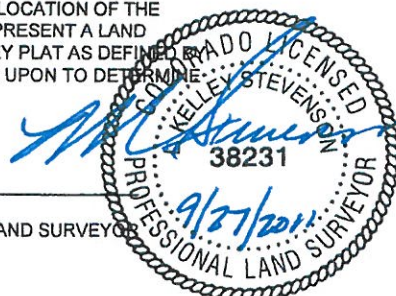
