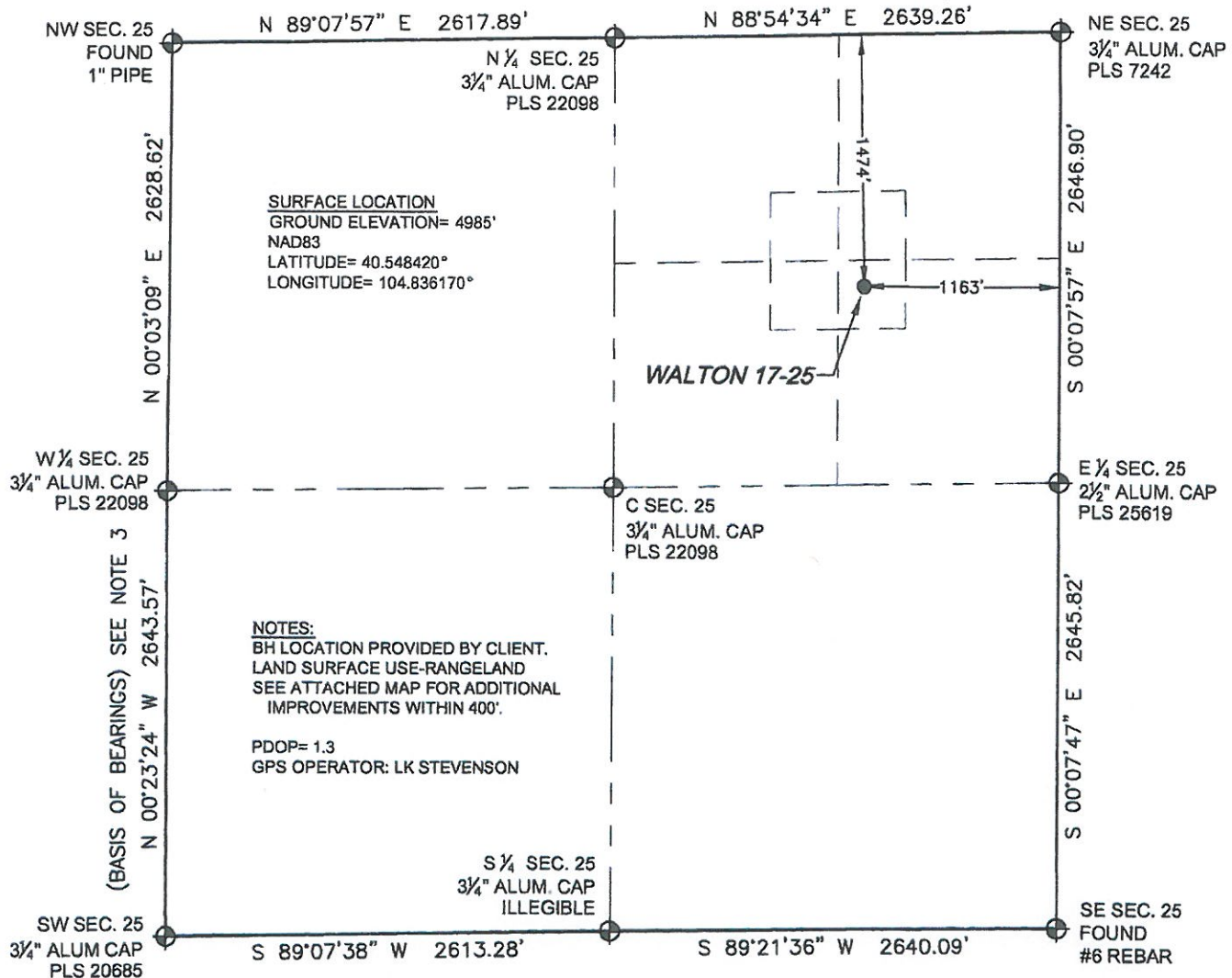


WELL LOCATION CERTIFICATE: WALTON 17-25

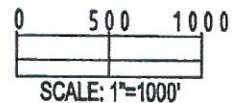

● = PROPOSED WELL ♦ = EXISTING WELL

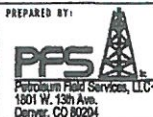
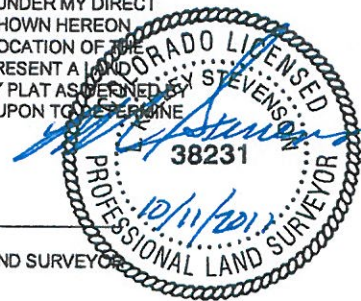
