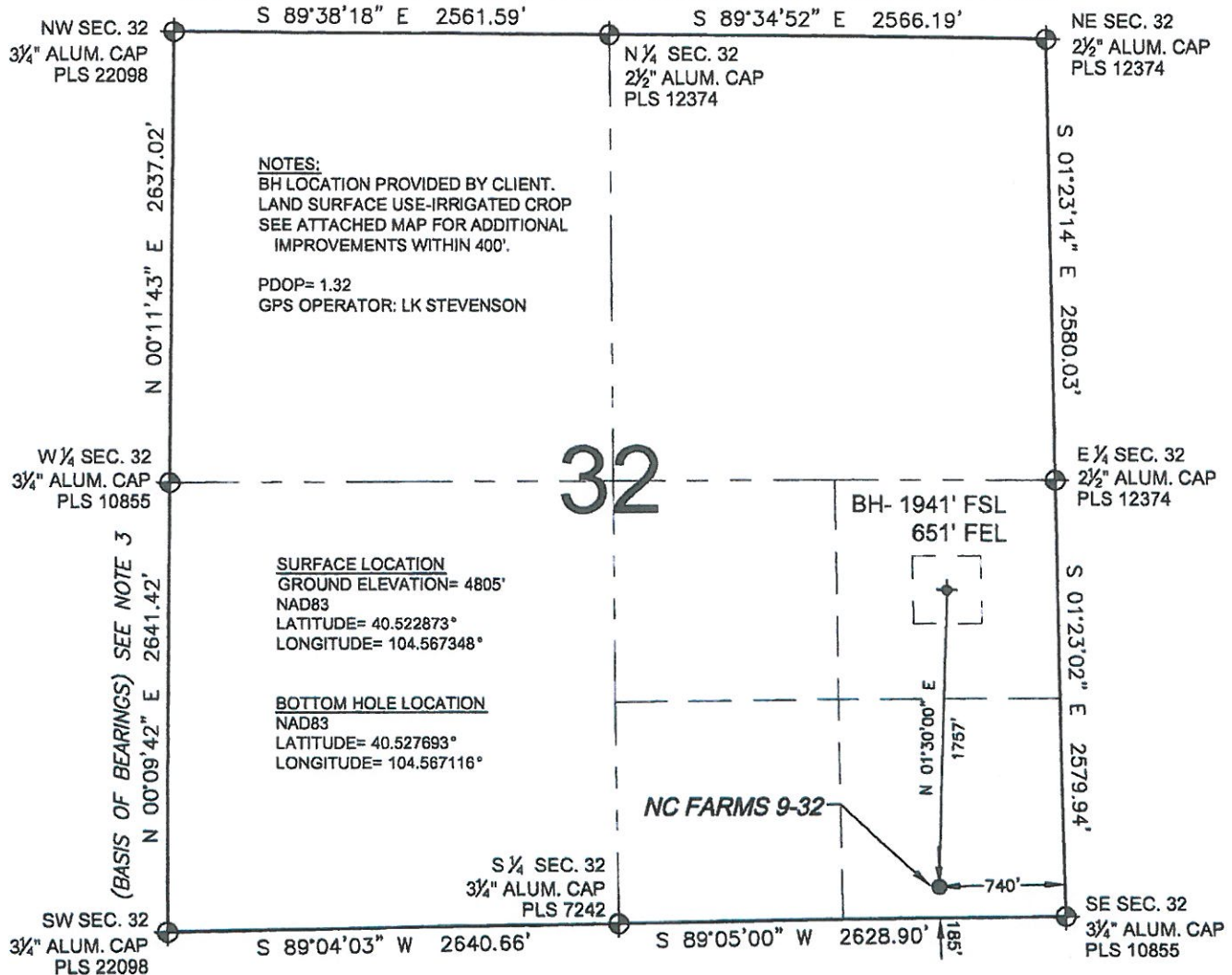


WELL LOCATION CERTIFICATE: NC FARMS 9-32
