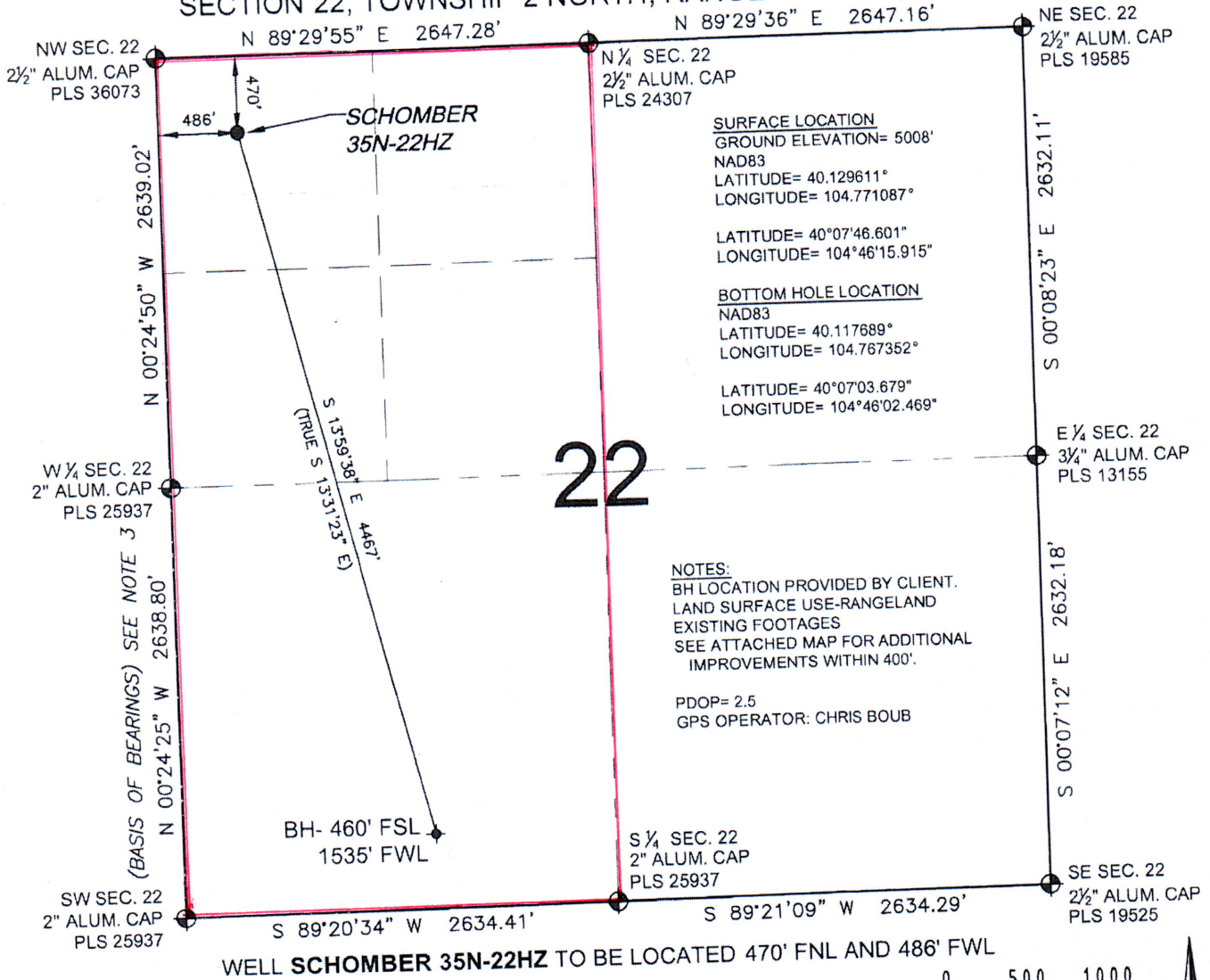

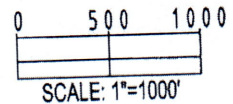
WELL LOCATION CERTIFICATE: SCHOMBER 35N-22HZ

- BH = BOTTOM HOLE

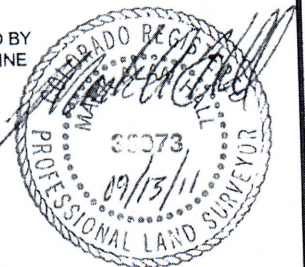
