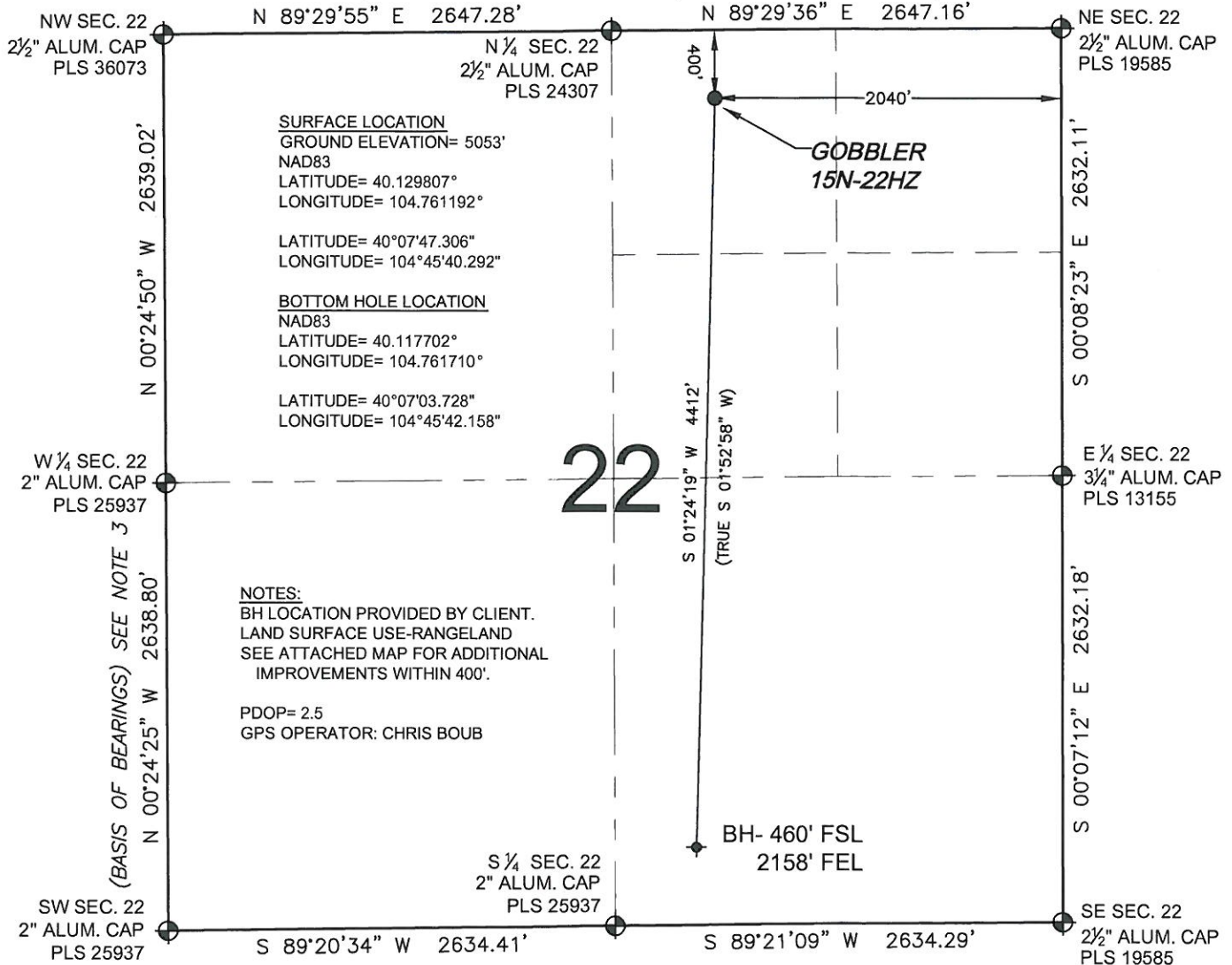


# WELL LOCATION CERTIFICATE: GOBBLER 15N-22HZ
