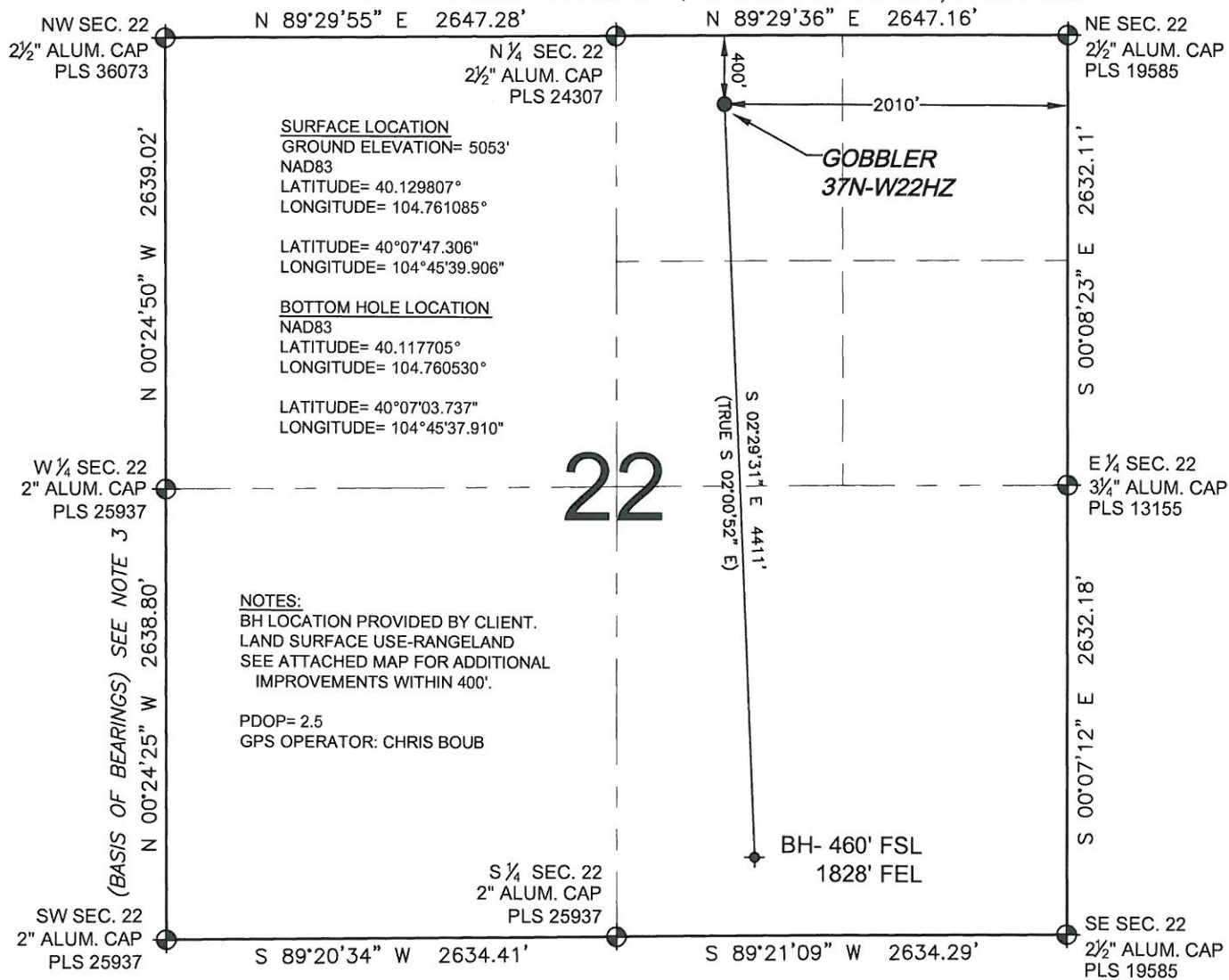


WELL LOCATION CERTIFICATE: GOBBLER 37N-W22HZ

SECTION 22, TOWNSHIP 2 NORTH, RANGE 66 WEST, 6TH P.M.

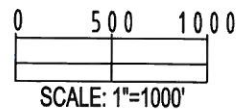
