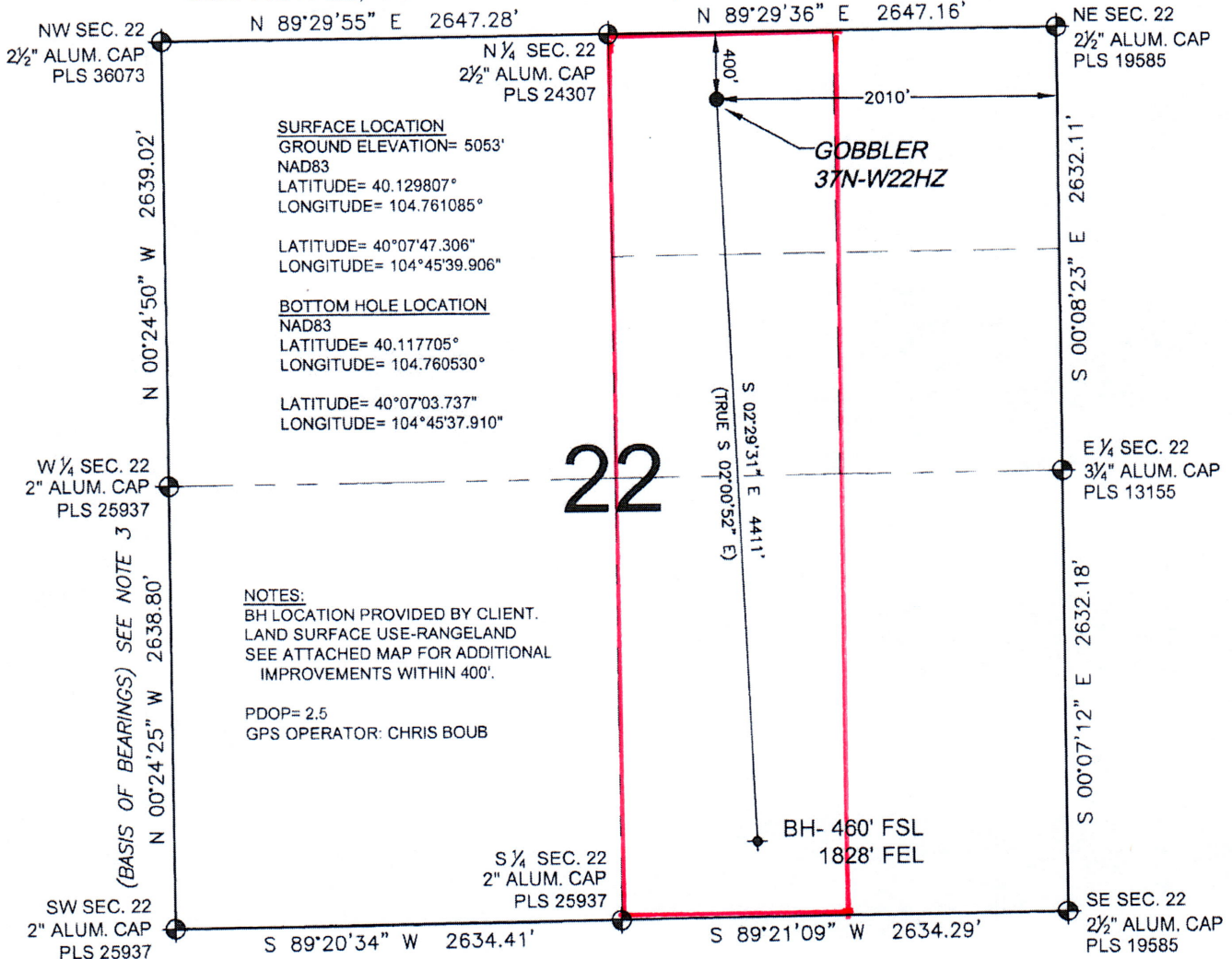

WELL LOCATION CERTIFICATE: GOBBLER 37N-W22HZ

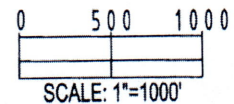

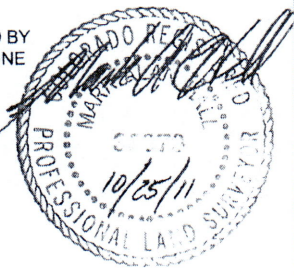
