Enclosed are copies of the following documents to assist you in your review and approval of NEI's proposed APD for the captioned well:



Proposed 160 acre spacing unit




Bottom Hole Location



That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
