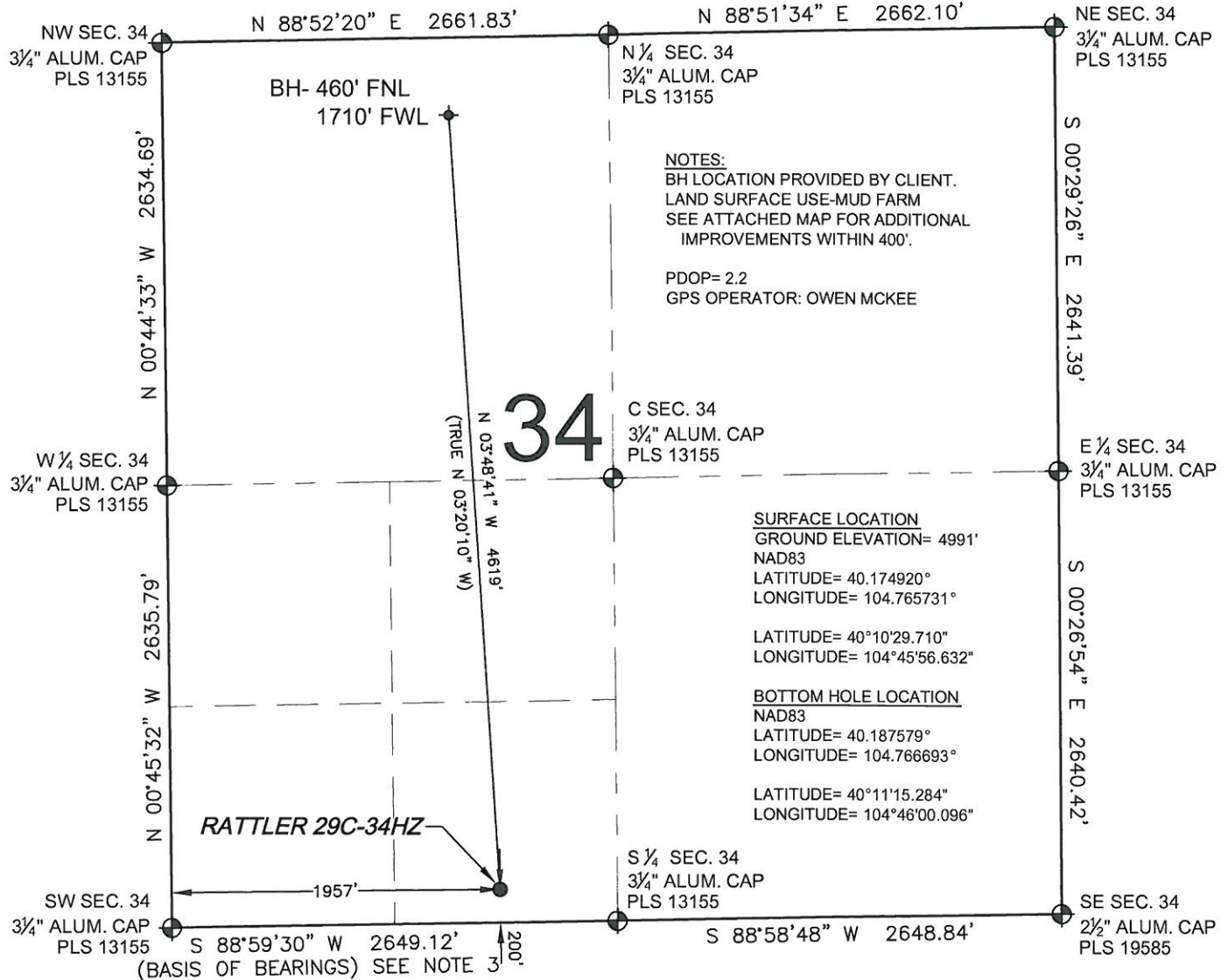


WELL LOCATION CERTIFICATE: RATTLER 29C-34HZ
