
Per your discussions with Don Barbula with Bayswater Exploration & Production, LLC (Bayswater,) we plan to drill two new oil and gas wells located on property for which you are the surface owner of record in the W/2 of Section 4, Township 1 South, Range 67 West, Adams County, Colorado. Pursuant to Rule 305 of the rules of the Colorado Oil and Gas Conservation Commission (COGCC) Bayswater provides the following information to you:

1. The operator of the captioned well is Bayswater Exploration & Production, LLC.
2. Bayswater intends to commence operations for the drilling of the captioned wells in the near future. Due to rig availability and scheduling, we estimate the commencement of operations with heavy equipment, as soon as the first part of January 2012.
3. The location of the captioned wells is referenced above and more specifically identified on the well location certificates enclosed with this letter.
4. Under the COGCC rules the surface owner is responsible for notifying any affected tenant of the proposed operations.
5. Under COGCC Rule 306, the affected surface owner is entitled to a consultation with the operator.
6. Also enclosed is a copy of the COGCC's informational brochure for surface owners containing rules pertaining to notice of oil and gas operations and opportunities for consultation thereon.
7. Further, enclosed is a copy of the COGCC's Onsite Inspection Policy.

Additionally, as you discussed with Mr. Barbula, we will contact you shortly regarding a surface damage agreement covering the locations.

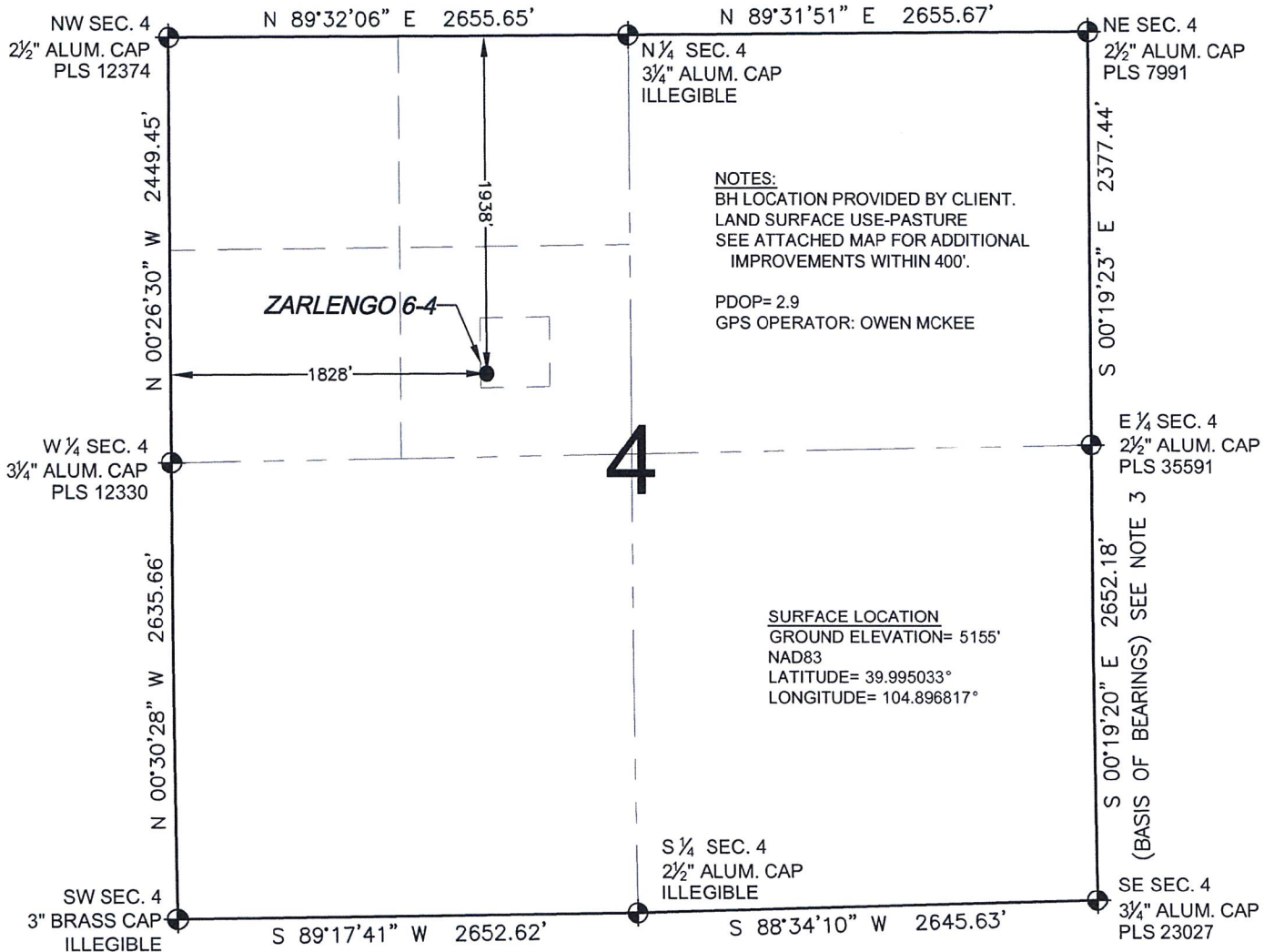

WELL LOCATION CERTIFICATE: ZARLENGO 6-4

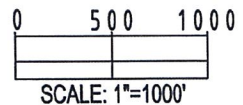
SECTION 4, TOWNSHIP 1 SOUTH, RANGE 67 WEST, 6TH P.M.

● = PROPOSED WELL ♦ = EXISTING WELL

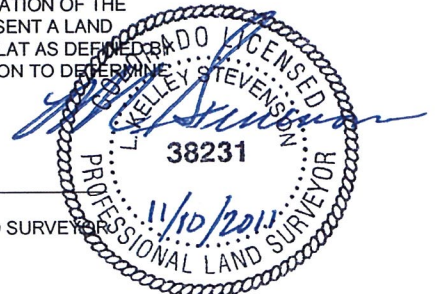

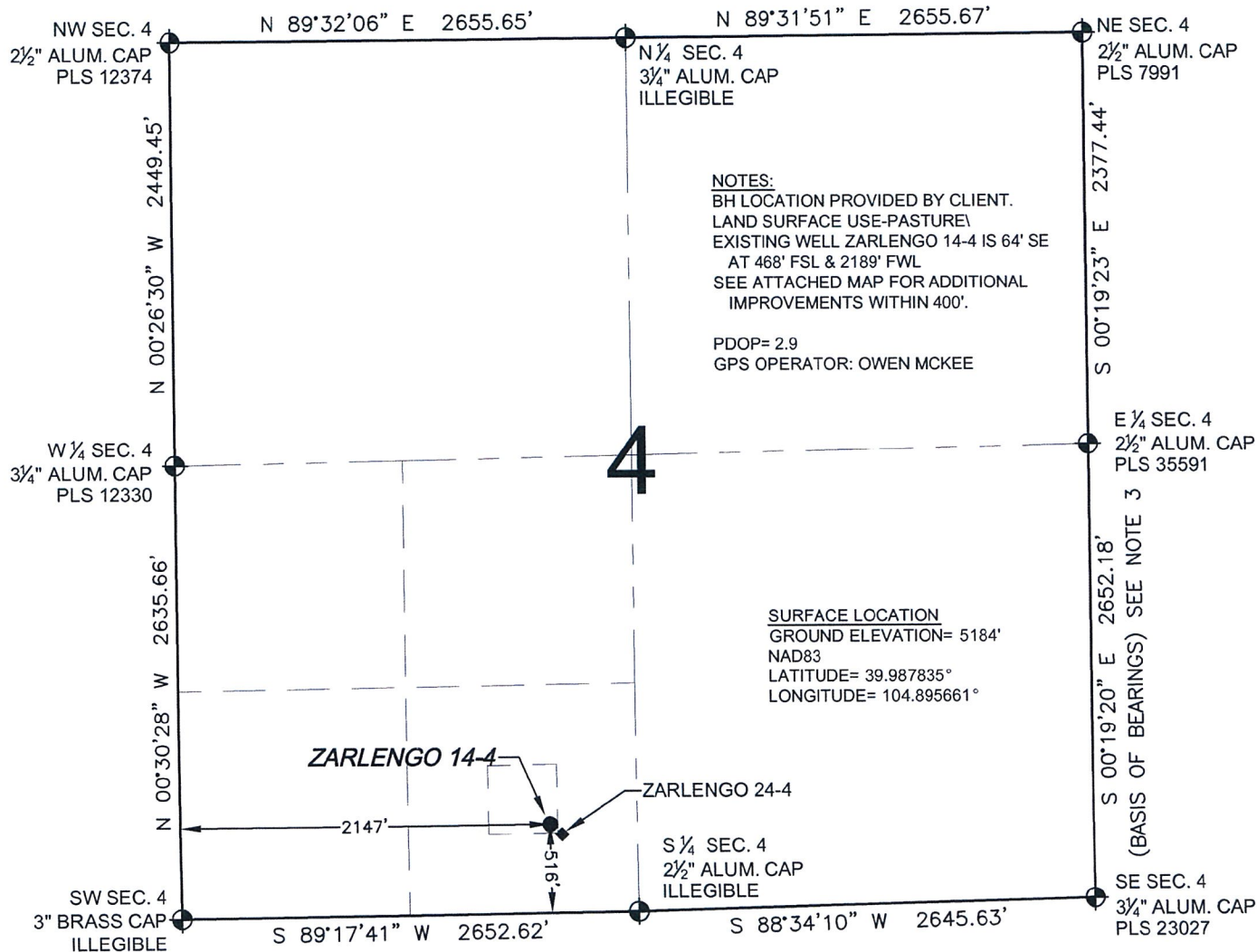

WELL LOCATION CERTIFICATE: ZARLENGO 14-4

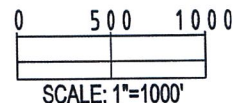

● = PROPOSED WELL ◆ = EXISTING WELL

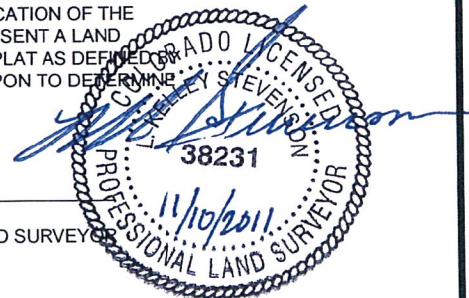
