Catherine,

Since the pits will contain only precipitation and snowmelt, we don't have concerns for migratory birds accessing the water that would accumulate from precipitation over winter. Regarding the

fencing, keep in mind that we have had big game become entrapped and die in lined pits due to the slippery nature of the liner. If you are constructing an 8-foot deer fence to exclude big game this won't be an issue. If not, we should discuss this issue.

Jon,

I spoke with Greg Deranleau (COGCC) this afternoon about our COAs for the McIntyre Flowback Pits #3 & #4. SG Interests would like to construct these pits and line them this fall. We plan to fence the pit facility this fall, but we do not plan to put any water in the pits until next spring. I told Greg that because we do not plan to fill the pits this fall, we do not plan to net them until spring. He asked that I notify you of our intent to construct, but not fill the pits this year. The pits would hold some amount of precipitation and snow melt over the winter months, but nothing would be added to this water. Please contact me if you have any comments or questions concerning our construction plans for the McIntyre Pits this fall. Thank you.
