This is the closest water well to location and has a reported depth to GW of 23' with no elevation reported- thus no changes have been made due to elevation differences. Location is listed as a sensitive area due to its proximity to surface and ground water. Operator requests a Rule 318A.a and 318A.c exception location; waiver and request are attached. Reference area is immediately adjacent to location to the south, location pictures are therefore reference area pictures. Three wells are currently being permitted on this site, as listed under "Related Forms", the remaining wells will be permitted once legal matters have been worked out.
