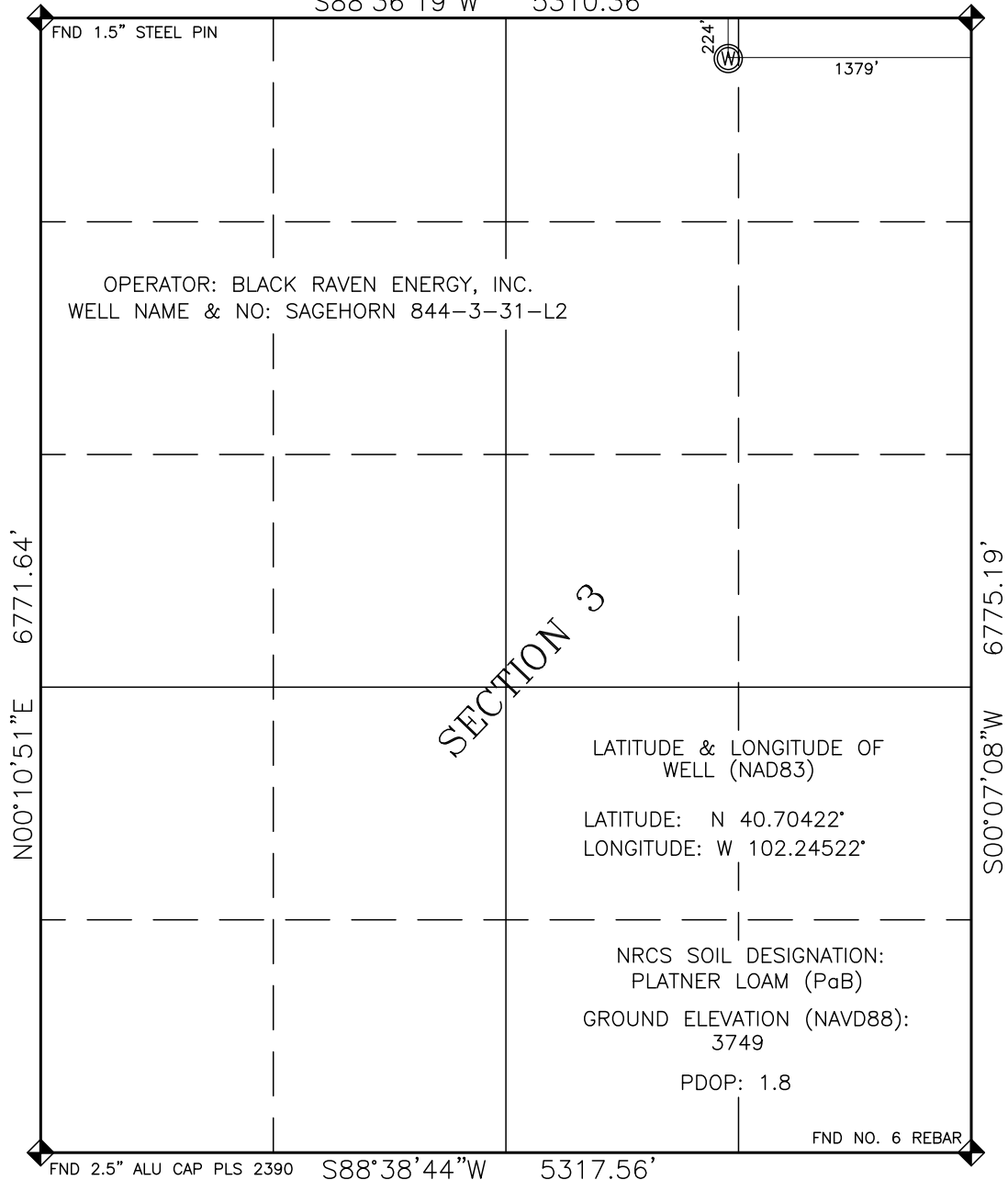


COLORADO WELL LOCATION
