


WELL LOCATION CERTIFICATE

Petroleum Field Services, LLC has determined the surface location of the FURROW FEDERAL PC AB14-62HN to be 1582' from the SOUTH line and 250' from the WEST line and the bottom hole to be 660' from the SOUTH line and 535' from the EAST line as measured at right angles from the section line of Section 14, Township 7 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 07/05/11, for and on behalf of Noble Energy Inc., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
